#### 1.5 Measurement Results Explanation Example

#### For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + Power Splitter + attenuator factor..

Following shows an offset computation example with cable loss 1.5dB; There are two power dividers, 3dB and 4.5dB respectively; 10dB attenuator.

Example:

Offset (dB) = RF cable loss(dB) + Power Splitter (dB) + attenuator factor(dB). = 1.5 + 7.5 + 10 = 19 (dB)


#### 2.1.1 Requirement

According to FCC section 2.1046(a), for transmitters other than single sideband, independent sideband and controlled carrier radiotelephone, power output shall be measured at the RF output terminals when the transmitter is adjusted in accordance with the tune-up procedure to give the values of current and voltage on the circuit elements specified in FCC section 2.1033(c)(8).

#### 2.1.4 Test Procedures

- 1. The transmitter output port was connected to the system simulator.
- 2. Set EUT at maximum power through system simulator.
- 3. Select lowest, middle, and highest channels for each band and different modulation.
- 4. Measure and record the power level from the system simulator.

#### 2.2 Peak to Average Radio


#### 2.2.1 Definition

Power Complementary Cumulative Distribution Function (CCDF) curves provide a means for characterizing the power peaks of a digitally modulated signal on a statistical basis. A CCDF curve depicts the probability of the peak signal amplitude exceeding the average power level. Most contemporary measurement instrumentation include the capability to produce CCDF curves for an input signal provided that the instrument's resolution bandwidth can be set wide enough to accommodate the entire input signal bandwidth. In measuring transmissions in this band using an average power technique, the peak-to-average ratio (PAR) of the transmission may not exceed 13 dB.

#### 2.2.3 Test Description



#### 2.2.4 Test Procedures

- 1. The EUT was connected to spectrum and system simulator via a power divider.
- 2. Set the CCDF (Complementary Cumulative Distribution Function) option in spectrum analyzer.
- 3. The highest RF powers were measured and recorded the maximum PAPR level associated with a probability of 0.1 %.
- 4. Record the deviation as Peak to Average Ratio.

#### 2.3 99% Occupied Bandwidth and 26dB Bandwidth

#### 2.3.1 Definition


According to FCC section 2.1049, the occupied bandwidth is the width of a frequency band such that, below the lower and above the upper frequency limits, the mean powers emitted are each equal to a specified percentage 0.5% of the total mean transmitted power.

The 26 dB emission bandwidth is defined as the frequency range between two points, one above and one below the carrier frequency, at which the spectral density of the emission is attenuated 26 dB below the maximum in-band spectral density of the modulated signal. Spectral density (power per unit bandwidth) is to be measured with a detector of resolution bandwidth equal to approximately 1.0% of the emission bandwidth.

#### 2.3.4 Test Procedures

- 1. The EUT was connected to spectrum analyzer and system simulator via a power divider.
- 2. The 26dB and 99% occupied bandwidth (BW) of the middle channel for the highest RF power with full RB sizes were measured.





























#### 2.4 Frequency Stability

#### 2.4.1 Requirement


According to FCC requirement, the frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block. The frequency stability shall be measured by variation of ambient temperature and variation of primary supply voltage to ensure that the fundamental emission stays within the authorized frequency block. The frequency stability of the transmitter shall be maintained within  $\pm 0.00025\%$  ( $\pm 2.5$ ppm) of the center frequency. According to FCC section 2.1055, the test conditions are:

- (a) The temperature is varied from  $-30 \, \text{C}$  to  $+50 \, \text{C}$  at intervals of not more than  $10 \, \text{C}$ .
- (b) For hand carried battery powered equipment, the primary supply voltage is reduced to the battery operating end point which shall be specified by the manufacture. The supply voltage shall be measured at the input to the cable normally provided with the equipment, or at the power supply terminals if cables are not normally provided.

#### 2.4.3 Test Setup



#### 2.4.4 Test Procedures

- 1. The EUT was set up in the thermal chamber and connected with the system simulator.
- 2. With power OFF, the temperature was decreased to -30 °C and the EUT was stabilized before



testing. Power was applied and the maximum change in frequency was recorded within one minute.

- 3. With power OFF, the temperature was raised in 10 °C step up to 50 °C. The EUT was stabilized at each step for at least half an hour. Power was applied and the maximum frequency change was recorded within one minute.
- 4. The nominal, highest and lowest extreme voltages were tested, which are specified by the applicant; the normal temperature here used is  $25 \, \text{C}$ .
- 5. The variation in frequency was measured for the worst case.

#### 2.5 Conducted Out of Band Emissions

#### 2.5.1 Requirement


The power of any emission outside of the authorized operating frequency ranges must be lower than the transmitter power (P) by a factor of at least  $43 + 10 \log (P) dB$ .

It is measured by means of a calibrated spectrum analyzer and scanned from 30 MHz up to a frequency including its 10th harmonic.

#### 2.5.3 Test Setup



#### 2.5.4 Test Procedures

- 1. The EUT was connected to spectrum analyzer and system simulator via a power divider.
- 2. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.
- 3. The middle channel for the highest RF power within the transmitting frequency was measured.
- 4. The conducted spurious emission for the whole frequency range was taken.
- 5. Make the measurement with the spectrum analyzer's RBW = 1MHz, VBW = 3MHz, taking the record of maximum spurious emission.
- 6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.



7. The limit line is derived from  $43 + 10\log(P)dB$  below the transmitter power P(Watts)

$$= P(W)- [43 + 10log(P)] (dB)$$



- = -13dBm.
- 8. For 9KHz to 30MHz: the amplitude of spurious emissions which are attenuated by more than 20dB below the permissible value has no need to be reported.


#### 2.6.1 Description of Conducted Band Edge Measurement

Out of band emissions. The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least  $43 + 10 \log(P) dB$ .



- 1. The testing follows FCC KDB 971168 v03r01 Section 6.0.
- 2. The EUT was connected to spectrum analyzer and system simulator via a power divider.
- 3. The band edges of low and high channels for the highest RF powers were measured.
- 4. Set RBW >= 1% EBW in the 1MHz band immediately outside and adjacent to the band edge.
- 5. Beyond the 1 MHz band from the band edge, RBW=1MHz was used.
- 6. Set spectrum analyzer with RMS detector.
- 7. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.
- 8. Checked that all the results comply with the emission limit line.

  The limit line is derived from 43 + 10log(P)dB below the transmitter power P(Watts)
- 9. For LTE Band 7 the other 40 dB, and 55 dB have additionally applied same calculation above.




























































#### 2.7.1 Requirement

Effective radiated power output measurements by substitution method according to ANSI / TIA / EIA-603-D-2010, and the spectrum analyzer configuration follows KDB 971168 D01 Power Meas. License Digital Systems v03r01. Mobile and portable (hand-held) stations operating are limited to average ERP of 7 watts with LTE band 5 Equivalent isotropic radiated power output measurements by substitution method according to ANSI / TIA / EIA-603-D-2010, and the spectrum analyzer configuration follows KDB 971168 D01 Power Meas. License Digital Systems v03r01.

#### 2.7.4 Test Procedures

- 1. The EUT was placed on a turntable with 1.5 meter height in a fully anechoic chamber.
- 2. The EUT was set at 3 meters from the receiving antenna, which was mounted on the antenna tower.
- 3. The radiated emission at the fundamental frequency was measured at 3 m with a test antenna and a spectrum analyzer which used a channel power option across EUT's signal bandwidth per section 4.0 of KDB 971168 D01v03r01.
- 4. The table was rotated 360 degrees to determine the position of the highest radiated power.
- 5. The height of the receiving antenna is adjusted to look for the maximum ERP/EIRP.
- 6. Taking the record of maximum ERP/EIRP.
- 7. A dipole antenna was substituted in place of the EUT and was driven by a signal generator.
- 8. The conducted power at the terminal of the dipole antenna is measured.
- 9. Repeat step 3 to step 5 to get the maximum ERP/EIRP of the substitution antenna.
- 10. ERP/EIRP = Ps + Et Es + Gs = Ps + Rt Rs + Gs

Ps (dBm): Input power to substitution antenna.

Gs (dBi or dBd): Substitution antenna Gain.

Et = Rt + AF

Es = Rs + AF

AF (dB/m): Receive antenna factor

Rt: The highest received signal in spectrum analyzer for EUT.

Rs: The highest received signal in spectrum analyzer for substitution antenna.


The radiated spurious emission was measured by substitution method according to ANSI / TIA /EIA-603-C-2004. The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitter power (P) by a factor of at least 43 + 10 log (P) dB.




For radiated emissions from 9kHz to 30MHz












For radiated emissions above 1GHz







#### 2.8.4 Test Procedures

- 1. The EUT was placed on a rotatable wooden table with 0.8 meter above ground.
- 2. The EUT was set 3 meters from the receiving antenna, which was mounted on the antenna tower.
- 3. The table was rotated 360 degrees to determine the position of the highest spurious emission.
- 4. The height of the receiving antenna is varied between one meter and four meters to search the maximum spurious emission for both horizontal and vertical polarizations.
- 5. Make the measurement with the spectrum analyzer's RBW = 1MHz, VBW = 3MHz, taking the record of maximum spurious emission.
- 6. A horn antenna was substituted in place of the EUT and was driven by a signal generator.
- 7. Tune the output power of signal generator to the same emission level with EUT maximum spurious emission.
- 8. Taking the record of output power at antenna port.
- 9. Repeat step 7 to step 8 for another polarization.
- 10. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.

The limit line is derived from  $43 + 10\log(P)dB$  below the transmitter power P(Watts)

- 11. All Spurious Emission tests were performed in X, Y, Z axis direction and low, middle, high channel. And only the worst axis test condition was recorded in this test report.
- 12. The spectrum is measured from 9 KHz to the 10<sup>th</sup> harmonic of the fundamental frequency of the transmitter using CISPR quasi peak detector below 1GHz. The worst case emissions are reported however emissions whose levels were not within 20dB of the respective limits were not reported.
- 13. The maximum RB configurations of the Radiated Spurious Emissions as RB Size 1, RB Offset 0.
