



# Charging the Battery


**Checking the Battery Level** 

Press the Battery Level Button once to check the battery level, and press again to power off.



## Charging


Install the battery into the standard charging hub, and connect the plug the connector B of the battery charger to the charging hub, then connect the battery charger to a power outlet (100-240V, 50/60Hz).



Tips: The charging hub can charge two batteries at the same time. It will take a longer time to charge the Intelligent Flight Battery and remote controller together.

# Mounting the Battery


Put the battery into the Battery Slot, then push it to the end until you hear a click.

# Connecting the Display Screen to the Remote Controller


Connect the display screen to the remote controller via a Micro USB cable.



# DJI GO/GO 4 App
