# 4. REQUIREMENT

## **LIMIT AND CALCULATION METHOD**

Systems operating under the provisions of FCC 47 CFR section shall be operated in a manner that ensures that the public is not exposed to radio frequency energy level in excess of the Commission's guidelines.

In accordance with 47 CFR FCC Part 2 Subpart J, section 2.1091 this device has been defined as mobile device whereby a distance of 0.2m normally can be maintained between the user and the device, and below RF Permissible Exposure limit shall comply with.

G=power gain of the antenna in the direction of interest relative to an isotropic radiator

R=distance to the center of radiation of the antenna

#### Note:

- 1. The Power comes from operation description.
- 2. All the modes had been tested, but only the worst data was recorded in the report.
- 3. The assess distance is 20 cm.
- 4. Only WIFI 2.4G & SRD 5G, BLE & SRD 5G, WIFI 5G & SRD 2.4G can transmit simultaneously.

WIFI 2.4 GHz + SRD 5G =  $0.01773 + 0.28102 = 0.29875 \text{ (mW/cm}^2)$ ,

BLE + SRD 5G =  $0.00079 + 0.28102 = 0.28181 \text{ (mW/cm}^2)$ ,

WIFI 5 GHz + SRD  $2.4G = 0.02505 + 0.25046 = 0.27551 \text{ (mW/cm}^2),}$ 

therefor the maximum calculations of above situations are less than the "1" limit.
