Objective

This report is prepared on behalf of SZ DJI TECHNOLOGY CO., LTD in accordance with Part 2, Subpart J, Part 15, Subparts A, B and C of the Federal Communications Commission's rules

The tests were performed in order to determine the compliance of the EUT with FCC Part 15-Subpart C, section 15.203, 15.205, 15.207, 15.209 and 15.247 rules.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.4-2009, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed and Bay Area Compliance Laboratories Corp. (Dongguan).

Test Facility

The Test site used by Bay Area Compliance Laboratories Corp. (Dongguan) to collect test data is located on the No.69 Pulongcun, Puxinhu Industrial Zone, Tangxia, Dongguan, Guangdong, China


EUT Exercise Software

The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the user of a standard antenna jack or electrical connector is prohibited. 



The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.4-2009. The specification used was the FCC 15.209, and FCC 15.247 limits.

The spacing between the peripherals was 10 cm.

Test Procedure

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

Data was recorded in Quasi-peak detection mode for frequency range of 30 MHz-1 GHz, peak and Average detection modes for frequencies above 1 GHz.

Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Loss and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:




Antenna 2 Middle Channel




Antenna 3 Low Channel




Antenna 3 High Channel

Antenna 4 Low Channel




Antenna 4 Middle Channel

Test Procedure

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Position the EUT without connection to measurement instrument. Turn on the EUT and connect it to measurement instrument. Then set it to any one convenient frequency within its operating range. Set a reference level on the measuring instrument equal to the highest peak value.
- 3. Measure the frequency difference of two frequencies that were attenuated 6 dB from the reference level. Record the frequency difference as the emission bandwidth.
- 4. Repeat above procedures until all frequencies measured were complete.





Antenna 1 Middle Channel




Antenna 1 High Channel




Antenna 2 Middle Channel




Antenna 3 Low Channel

Antenna 3 Middle Channel




Antenna 3 High Channel




Antenna 4 Middle Channel

FCC §15.247(b) (3) - MAXIMUM PEAK CONDUCTED OUTPUT POWER

Applicable Standard

According to FCC §15.247(b) (3), for systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.

Test Procedure

- 1. According to KDB 558074 D01 DTS Meas Guidance v03r02, place the EUT on a bench and set it in transmitting mode.
- 2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to a Test Equipment.

FCC §15.247(d) – 100 kHz BANDWIDTH OF FREQUENCY BAND EDGE

Applicable Standard

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

Test Procedure

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Position the EUT without connection to measurement instrument. Turn on the EUT and connect its antenna terminal to measurement instrument via a low loss cable. Then set it to any one measured frequency within its operating range, and make sure the instrument is operated in its linear range.
- 3. Set RBW to 100 kHz and VBW of spectrum analyzer to 300 kHz with a convenient frequency span including 100 kHz bandwidth from band edge.
- 4. Measure the highest amplitude appearing on spectral display and set it as a reference level. Plot the graph with marking the highest point and edge frequency.
- 5. Repeat above procedures until all measured frequencies were complete.




Antenna 1: Band Edge, Left Side

Antenna 1: Band Edge, Right Side




Antenna 2: Band Edge, Left Side

Antenna 2: Band Edge, Right Side




Antenna 3 Band Edge, Left Side

Antenna 3 Band Edge, Right Side




Antenna 4 Band Edge, Left Side

FCC §15.247(e) - POWER SPECTRAL DENSITY

For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission. 


Power Spectral Density, Antenna 1 Low Channel

Power Spectral Density, Antenna 1 Middle Channel





Power Spectral Density, Antenna 2 Low Channel





Power Spectral Density, Antenna 2 High Channel




Power Spectral Density, Antenna 3 Low Channel

Power Spectral Density, Antenna 3 Middle Channel





Power Spectral Density, Antenna 4 Low Channel




Power Spectral Density, Antenna 4 Middle Channel

Power Spectral Density, Antenna 4 High Channel







Power Spectral Density, Antenna 1 Middle Channel





Power Spectral Density, Antenna 2 Low Channel





Power Spectral Density, Antenna 2 High Channel





Power Spectral Density, Antenna 3 Middle Channel





Power Spectral Density, Antenna 4 Low Channel




