#### **Product Description for Equipment under Test (EUT)**

The SZ DJI TECHNOLOGY CO., LTD's product, model number: W323A (FCC ID: SS3-WM3231507) (the "EUT") in this report was a Phantom 3 Professional, which was measured approximately: 50cm (L) x 50 cm (W) x 18.5 cm(H), rated input voltage: DC 15.2V from lithium battery or DC 17.5V from adapter.

#### **Objective**

This report is prepared on behalf of *SZ DJI TECHNOLOGY CO., LTD* in accordance with Part 2, Subpart J, Part 15, Subparts A, B and C of the Federal Communications Commission's rules

The tests were performed in order to determine the compliance of the EUT with FCC Part 15-Subpart C, section 15.203, 15.205, 15.207, 15.209 and 15.247 rules.

## **Test Methodology**

All measurements contained in this report were conducted with ANSI C63.4-2009, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed and Bay Area Compliance Laboratories Corp. (Dongguan).

#### **Test Facility**

The Test site used by Bay Area Compliance Laboratories Corp. (Dongguan) to collect test data is located on the No.69 Pulongeun, Puxinhu Industrial Zone, Tangxia, Dongguan, Guangdong, China

Test site at Bay Area Compliance Laboratories Corp. (Dongguan) has been fully described in reports submitted to the Federal Communications Commission (FCC). 

The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the user of a standard antenna jack or electrical connector is prohibited. The structure and application of the EUT were analyzed to determine compliance with section §15.203 of the rules. §15.203 state that the subject device must meet the following criteria:





The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.4-2009. The specification used was the FCC 15.209, and FCC 15.247 limits.

The spacing between the peripherals was 10 cm.

#### **EMI Test Receiver & Spectrum Analyzer Setup**

The system was investigated from 30 MHz to 25 GHz.

#### **Test Procedure**

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

Data was recorded in Quasi-peak detection mode for frequency range of 30 MHz-1 GHz, peak and Average detection modes for frequencies above 1 GHz.

### **Corrected Amplitude & Margin Calculation**

The Corrected Amplitude is calculated by adding the Antenna Loss and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Loss + Cable Loss - Amplifier Gain

The "Margin" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7dB means the emission is 7dB below the limit. The equation for margin calculation is as follows:





Systems using digital modulation techniques may operate in the 902–928 MHz, 2400–2483.5 MHz, and 5725–5850 MHz bands. The minimum 6 dB bandwidth shall be at least 500 kHz.

#### **Test Procedure**

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Position the EUT without connection to measurement instrument. Turn on the EUT and connect it to measurement instrument. Then set it to any one convenient frequency within its operating range. Set a reference level on the measuring instrument equal to the highest peak value.
- 3. Measure the frequency difference of two frequencies that were attenuated 6 dB from the reference level. Record the frequency difference as the emission bandwidth.
- 4. Repeat above procedures until all frequencies measured were complete.


#### **Antenna 2 Middle Channel**


#### **Antenna 4 Middle Channel**

## FCC §15.247(b) (3) - MAXIMUM PEAK CONDUCTED OUTPUT POWER

#### **Applicable Standard**

According to FCC §15.247(b) (3), for systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.

#### **Test Procedure**

- 1. According to KDB 558074 D01 DTS Meas Guidance v03r02, place the EUT on a bench and set it in transmitting mode.
- 2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to a Test Equipment.

## FCC §15.247(d) – 100 kHz BANDWIDTH OF FREQUENCY BAND EDGE

#### **Applicable Standard**

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. 



#### Antenna 1: Band Edge, Right Side




## Antenna 2: Band Edge, Left Side




#### Antenna 3 Band Edge, Left Side

#### Antenna 3 Band Edge, Right Side




#### Antenna 4 Band Edge, Left Side

## FCC §15.247(e) - POWER SPECTRAL DENSITY





## Power Spectral Density, Antenna 1 Middle Channel



#### Power Spectral Density, Antenna 3 Middle Channel





## Power Spectral Density, Antenna 4 Low Channel




