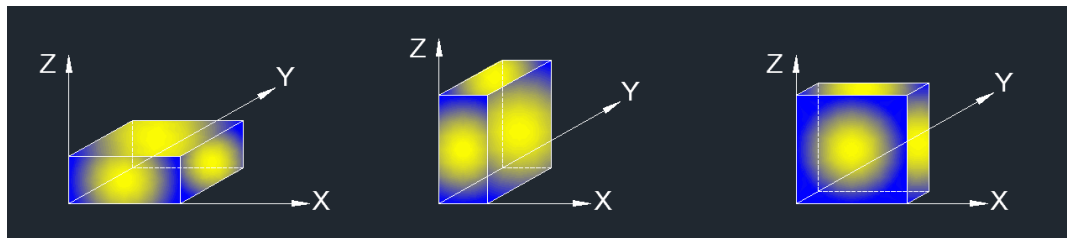

TEST PROCEDURE
