>> Question #1: Operational description is requested as confidential document but the information contains in the file are general information which can not be considered as confidential information to the applicant. Please remove operational description from the request letter.

>> ==> Enclosed please find a revised confidential letter.

>> Question #2: Based upon the external photos and internal photos, the antenna is built in the PDA . However, section 1-2 hardware specification shows external integral antenna which does not agree with external and internal photos. Please explain.

>> ==>Yes, You are correct. The external antenna on the section 1-2 in the manual is for inserting CDMA Module in the EUT.

> That means the EUT use WLAN or CDMA Module, but this EUT is only for WLAN Module. If the WLAN is inserted into the EUT, the antenna port shall be closed with plastic cap, but the manual will be use for WLAN and CDMA module. In this case, what can they do?

>> Question #3: Section 1-2 of user manual indicates CF slot, please explain the function of this CF slot and the typical device will be used.

>>=> The CF Slot for the EUT is for external barcode scanner, or Memory Card. But when the WLAN module was inserted into the EUT, the CF Slot can not be use for above device, because the space for the memory card or external device in the device is replaced with WLAN Module.

>> Question #4: This device is equipped with earphone, speaker and microphone functions. Please explain how these functions will be used.

>> ==> The above mentioned port is for CDMA Module. If the CDMA Module is inserted into the EUT, we will re-submit this project to you. In this case, the above mentioned port does not work.

>> Question #5: Please consider to change the RF exposure warning statement to the following :

>> Important Note: To comply with FCC RF exposure compliance requirements, the antenna used for this transmitter must not be co-located or operating in conjunction with any other antenna or transmitter. This PDA is designed to be used for hand-held operation only.

> ==> O. K. But if the EUT use CDMA Module, in this case how to change the manual. I think you mentioned important note is for only
