## 6. Standalone MPE Result

As declared by the Applicant, the EUT is a wireless device used in a fix application, at least 20 cm from any body part of the user or nearby persons; from the maximum EUT RF output power, the minimum separation distance, r =20cm, as well as the gain of the used antenna is 1dBi, the RF power density can be obtained.
