Requirement of Public Notice DA00-1407/ Part 15.212	
1. The modular transmitter must have its own RF shielding.	The module has its own RF shielding.
2. The modular transmitter must have buffered modulation/data inputs.	RM900B-M1 has only digital I/Os for data input or output. All these inputs are buffered in MCU (U2). Please see the schematic.pdf.
3. The modular transmitter must have its own power supply regulation.	All power lines derived from the host device are regulated before energizing other circuits internal to the RM900B-M1. Please see the schematic.pdf.
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).	The application is intended for professional installation only.
5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing.	The RM900B-M1 was tested in a stand-alone configuration.
6. The modular transmitter must be labeled with its own FCC ID number, and, if the FCC ID is not visible when the module is installed inside another device, then the outside of the device into which the module is installed must also display a label referring to the enclosed module.	The label position of RM900B-M1 is clearly indicated. Please see the "SU3RM900B-M1_FCC label.pdf".

The modular transmitter must comply with any specific rule or operating requirements applicable to the transmitter and the manufacturer must provide adequate instructions along with the module to explain any such requirements. A copy of these instructions must be included in the application for equipment authorization.	The RM900B-M1 is compliant with all applicable FCC rules. Detail instructions are given in the Users Manual. Please see users manual.pdf.
8. The modular transmitter must comply with any applicable RF exposure requirements.
