**2.2 Assessment Results**

The highest EIRP adjusted with tune-up tolerance is 60.10dBuV/m – 95.3 = -35.2dBm = 0.0003mW < 738mW (Test Exclusion Thresholds of 50MHz at 190mm). Therefore, the SAR requirement is deemed to be satisfied without test.
