## 1. Declaration of RF exposure compliance for exemption from routine evaluation limits

	A portable device is defined as a transmitting device designed to be used in other than fixed locations and to generally be used in such a way that the RF source's radiating structure(s) is/are within 20 centimetres of the body of the user.
	Under §2.1093(c)(1) is stated that: Evaluation of compliance with the exposure limits in § 1.1310 is necessary for portable devices having single RF sources with more than an available maximum time-averaged power of 1 mW, more than the ERP listed in Table 1 to § 1.1307(b)(3)(i)(C), or more than the P <sub>th</sub> in the following formula, whichever is greater. The following formula shall only be used in conjunction with portable devices do not exempt by § 1.1307(b)(3)(i)(C) at distances from 0.5 centimetres to 20 centimetres and frequencies from 0.3 GHz to 6 GHz:
	$ERP_{20 cm}(d/20 \text{ cm})^x  d \le 20 \text{ cm}$
	$P_{th} (mW) = \begin{cases} ERP_{20 \ cm} (d/20 \ cm)^{\chi} & d \le 20 \ cm \\ ERP_{20 \ cm} & 20 \ cm < d \le 40 \ cm \end{cases}$
	Where
	$x = -\log_{10}\left(\frac{60}{ERP_{20} cm\sqrt{f}}\right) \text{ and f is in GHz;}$
4.3.1. Standalone SAR test exclusion	
considerations:	$ERP_{20\ cm}\ (\text{mW}) = \begin{cases} 2040f & 0.3\ \text{GHz} \le f < 1.5\ \text{GHz} \\ \\ 3060 & 1.5\ \text{GHz} \le f \le 6\ \text{GHz} \end{cases}$
	d = the minimum separation distance (cm) in any direction from any part of the device antenna(s) or radiating structure(s) to the body of the device user.
	f = is the lower operating frequency [GHz]
	Remark: If the ERP of a single RF source is not easily obtained, then the available maximum time-averaged power may be used in lieu of ERP if the physical dimensions of the radiating structure(s) do not exceed the electrical length of $\lambda/4$ or if the antenna gain is less than that of a half-wave dipole (1.64 linear value).
	CALCULATION
	According to ANSI C63.10-2013, § 9.5: EIRP = $E_{meas}$ + 20 Log ( $d_{meas}$ ) -104.7 where
	EIRP is the equivalent isotropically radiated power, in dBm E <sub>meas</sub> is the field strength of the emission at the measurement distance, in dBμV/m (see test report No.: 466676TRFWL, § 8.4) d <sub>meas</sub> is the measurement distance, in m
	Maximum Output Power = 69.1 + 20 Log (3) – 104.7 = -26.1 dBm = 0.0025 mW < 1 mW
	According to § 2.1093(c)(1), the product exempts from the SAR test requirements.
