2.2 Description of EUT:

The CCF3001B is a single button transmitter operating at 300 MHz. Encoding is performed by toggling the 10 DIP switches to either the on or off position. The CCF3001B is for use with automated gates, access control panels, or garage door openers that operate at 300 MHz and and is expected to have a transmit range of approximately 10 feet. The CCF3001B is powered by an A23, 12 volt, alkaline battery.

SECTION 3.0 TEST SPECIFICATION, METHODS & PROCEDURES

3.1 Test Specification:

3.2 Methods & Procedures:

3.2.1 §15.231

- (a) The provision of this section are restricted to periodic operation within the band 40.66-40.70 MHz and above 70 MHz. Except as Shown in paragraph (e) of this section, the intentional radiator is restricted to the transmission of a control signal such as those used with alarm systems, door openers, remote switches, etc. Radio control of toys in not permitted. Continuous transmissions, such as voice or video, and data transmissions are not permitted. The prohibition against data transmissions does not preclude the use of recognition codes. Those codes are used to identify the sensor that is activated or to identify the particular component as being part of the system. The following conditions shall be met to comply with the provisions for this periodic operation:
- (1) A manually operated transmitter shall employ a switch that will automatically deactivate the transmitter within not more than 5 seconds of being released.
- (2) A transmitter activated automatically shall cease transmission within 5 seconds after activation.
- (3) Periodic transmissions at regular predetermined intervals are not permitted. However, polling or supervision transmission to determine system integrity of transmitters used in security or safety applications are allowed if the periodic rate of transmission does not exceed one transmission of not more than one second duration per hour for each transmitter.
- (4) Intentional radiators which are employed for radio control purposes during emergencies involving fire, security, and

safety of life, when activated to signal an alarm, may operated during the pendency of the alarm condition.

(b) In addition to the provisions of §15.205, the field strength of emission from intentional radiators operated under this section shall not exceed the following:

- (1) the above field strength limits are specified at a distance of 3 meters. The tighter limits apply at the band edges.
- (2) Intentional radiators operating under the provisions of this section shall demonstrate compliance with the limits on the field strength of emissions, as shown in the above table, based on the average value of the measured emissions. As an alternative, compliance with the limits in the above table may be based on the use of measurement instrumentation with a CISPR quasi-peak detector. The specific method of measurement employed shall be specified in the application for equipment authorization. If average emission measurements are employed, the provision in \$15.35 for averaging pulsed emission and for limiting peak emissions apply. Further, compliance with the provisions of \$15.205 shall be demonstrated using the measurement instrumentation specified in that section.
- (3) The limits on the field strength of the spurious emission in the above table are based on the fundamental frequency of the intentional radiator. Spurious emission shall be attenuated to the average (or, alternatively, CISPR quasipeak) limits shown in this table or to the general limits shown in \$15.209, whichever limit permits a higher field strength.
- (c) The bandwidth of the emission shall be no wider than 0.25% of the center frequency for devices operating above 70 MHz and below 900 MHz. For devices operating above 900 MHz, the emission shall be no wider than 0.5% of the center frequency. Bandwidth is

determined at the points 20 dB down from the modulated carrier.

(d) For devices operation within the frequency band 40.66-40.70 MHz, the bandwidth of the emission shall be confined within the band edges and the frequency tolerance of the carrier shall be $\pm 0.01\%$. This frequency tolerance shall be maintained for a temperature variation of -20 degrees to +50 degrees C at normal supply voltage, and for a variation on the primary supply voltage from 85% to 115% of the rated supply voltage at a temperature of 20 degrees C. For battery operated equipment, the equipment tests shall be performed using a new battery.

(e) Intentional radiators may operate at a periodic rate exceeding that specified in paragraph (a) of this section and may be employed for any type of operation, including operation prohibited in paragraph (a) of this section, provided that intentional radiator complies with the provisions of paragraphs (b) through (d) of this section except the field strength table in paragraph (b) of this section is replaced by the following:

In addition, devices operated under the provisions of this paragraph shall be provided with a means for automatically limiting operation so that the duration of each transmission shall not be greater than one second and the silent periods between transmissions shall be at least 30 times the duration of the transmission but in no case less than 10 seconds.

3.2.2 §15.207 Conducted Limits

(a) Except for Class A digital devices, for equipment that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHZ to 30 MHz shall not exceed the limits in the following table, as measured using a 50 $\mu\text{H}/50$ ohms line impedance stabilization network (LISN). Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower limit applies at the band edges.

3.3 Test Procedure

The line conducted and radiated emissions testing was performed according to the procedures in ANSI C63.4 (2003). Testing was performed at CCL's Wanship open area test site #2, located at 550 West Wanship Road, Wanship, UT. This site has been fully described in a report submitted to the FCC, and was accepted in a letter dated August 11, 2003 (90504).

CCL participates in the National Voluntary Laboratory Accreditation Program (NVLAP) and has been accepted under NVLAP Lab Code:100272-0, which is effective until September 30, 2005.

For radiated emissions testing at 30 MHz or above that is performed at distances closer than the specified distance, an inverse proportionality factor of 20 dB per decade is used to normalize the measured data for determining compliance.

Power Supply: 12 volt alkaline battery

4.2 Operating Modes:

The CCF3001B was tested in a vertical position, a flat horizontal position, and a horizontal position with the front of the device perpendicular to the tabletop. The worst-case emissions were with the CCF3001B powered up with the button held down so the EUT would constantly transmit in the flat, horizontal position.



- 3. The CCF3001B does not transmit at regular predetermined intervals. The CCF3001B only transmits if manually activated.

6.2.2 §15.231 (b) Radiated Emissions

Demonstration of Compliance:

The CCF3001B operates at 300.0 MHz, therefore; the field strength of the fundamental must be less than 5416.77 $\mu\text{V/m}$ (74.7 dB $\mu\text{V/m})$ at 3 meters and the field strength of the spurious emissions must be less than 541.7 $\mu\text{V/m}$ (54.7 dB $\mu\text{V/m})$ at 3 meters.

The limits for a distance of 3 meters are determined using the formula:

Limit in the 260 - 470 MHz band = 41.6667(F) - 7083.3333

Where F is the frequency in MHz

Emissions in the restricted bands of \$15.205 must meet the limits specified in \$15.209.

Measurement Data Fundamental and Harmonic Emissions:


The frequency range from 30 MHz to the tenth harmonic of the highest fundamental frequency was investigated to measure any radiated emissions.

A diagram of the test configuration and test equipment used is enclosed in Appendix 1.

Pulsed Emission Averaging Factor

The CCF3001B transmitter is a pulsed emission device; therefore, the method of §15.35 for averaging a pulsed emission may be used. The plot of the pulse train and the average factor calculations are shown below:

Average factor calculation

From the plot, the there are 10 pulses in the pulse train at 1.575 msec each for a total on time of 15.75 msec and the complete pulse train is 40.1 msec.

An averaging factor to be applied to the measurements was calculated from the pulse train using the formula:

Averaging Factor = 20 log (T_{on} / PT)

Where T_{on} is the total of the transmit time of the pulse train and PT is the total time of one full pulse train

The calculation of the averaging factor for this device is shown below:

Averaging Factor = 20 log ((10 pulses x 1.575 ms)/ 40.1) = -8.1

The calculated averaging factor of -8.1 dB was applied to the peak detection measurements to achieve an average value measured emission as specified in paragraph (b) (1).

Sample Field Strength Calculation:

The field strength is calculated by adding the Correction Factor (Antenna Factor + Cable Factor) and the Average Factor to the measured level of the receiver. The receiver amplitude reading is compensated for any amplifier gain.

The basic equation with a sample calculation is shown below:

FS = RA + CF + AV Where

FS = Field Strength

RA = Receiver Amplitude Reading

CF = Correction Factor (Antenna Factor + Cable Factor)

AV = Averaging Factor

Assume a receiver reading of $46.4~\text{dB}\mu\text{V}$ is obtained from the receiver, with an average factor of -8.1~dB and a correction factor of 15.9 dB. The field strength is calculated by adding the correction factor and the average factor to the measurement value, giving a field strength of $54.2~\text{dB}\mu\text{V/m}$.

$$FS = 46.4 + 15.9 + (-8.1) = 54.2 \, dB_{\mu}V/m$$



6.2.3 \$15.231 (c) Bandwidth

Demonstration of Compliance:

The bandwidth of the emission must not be wider than 0.25% of the center frequency. The center frequency is 300 MHz, therefore the bandwidth must not be wider than 750 kHz. The CCF3001B bandwidth was 45 kHz, therefore it meets the bandwidth requirements. See spectrum analyzer plot below.

APPENDIX 1 TEST PROCEDURES AND TEST EQUIPMENT

Radiated Interference Emissions:

The radiated emission from the intentional radiator was measured using a spectrum analyzer. The resolution bandwidth was set at 100 kHz and the video bandwidth was set at 300 kHz. For peak emissions above 1000 MHz the spectrum analyzer's resolution bandwidth was set to 1 MHz and the video bandwidth was set to 3 MHz.

A biconilog antenna was used to measure the frequency range of 30 to 1000 MHz and a Double Ridge Guide Horn antenna was used to measure the frequency range 1 GHz to 3.0 GHz, at a distance of 3 meters from the EUT. The readings obtained by these antennas are correlated to the levels obtained with a tuned dipole antenna by adding antenna factors.

The configuration of the intentional radiator was varied to find the maximum radiated emission. The intentional radiator was rotated 360 degrees, and the antenna height was varied from 1 to 4 meters to find the maximum radiated emission. Where there were multiple interface ports all of the same type, cables are either placed on all of the ports or cables added to these ports until the emissions do not increase by more than 2 dB.

Desktop intentional radiator is measured on a non-conducting table one meter above the ground plane. The table is placed on a turntable which is level with the ground plane. The turntable has slip rings, which supply AC power to the intentional radiator. For equipment normally placed on floors, the equipment shall be placed directly on the turntable.






