5 RF Exposure Compliance Requirement

Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

6 RF Exposure Evaluation Result

The Max. Conducted Peak Output Power is 6.55dBm (4.52mW) based on the FCC RF report <SHEM130600102501>.

The best case gain of the antenna is 2.0dBi (convert to numeric 1.45).

According to the formula calculate the EIRP test result:

$$\text{EIRP} = P * G = 4.52 * 1.45 = 6.554\text{mW} \text{ ①}$$

SAR test exclusion power threshold is 19mW (at 10 mm distance, on 2450MHz band.) ②

$$\text{①} < \text{②}$$

So the SAR test is not required.
