### 4.1 FCC Radiofrequency radiation exposure limits:

According to §1.1310, the limit for general population/uncontrolled exposures

### 4.2 IC Radiofrequency radiation exposure limits:

According to RSS-102 section 2.5.2, RF exposure evaluation is required if the separation distance between the user and/or bystander and the device's radiating element is greater than 20 cm, except when the device operates as follows:

below 20 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 1 W (adjusted for tune-up tolerance);

- at or above 20 MHz and below 48 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than  $4.49/f^{0.5}$  W (adjusted for tune-up tolerance), where  $f$  is in MHz;
- at or above 48 MHz and below 300 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 0.6 W (adjusted for tune-up tolerance);
- at or above 300 MHz and below 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than  $1.31 \times 10^{-2} f^{0.6834}$  W (adjusted for tune-up tolerance), where  $f$  is in MHz;
- at or above 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 5 W (adjusted for tune-up tolerance).

For 2.4G device, the limit of worse case is 2.68 W

For 5G device, the limit of worse case is 4.5 W

## 5.2 MPE Calculation

For FCC:

For 2.4G WiFi

The best case gain of the antenna is 0dBi, 0dB logarithmic terms convert to numeric result is nearly 1

The Max Conducted Output Power is 36.14mW(0.036W);

For 5GHz WiFi

The best case gain of the antenna is 2.9dBi, 2.9dB logarithmic terms convert to numeric result is nearly 1.95

The Max Conducted Output Power is 12.59mW(0.012W);

According to the formula  $S = \frac{PG}{4R^2\pi}$ , we can calculate S which is MPE.

Note:

- 1) P (Watts) = Power Input to antenna =  $10^{\frac{dBm}{10}} / 1000$
- 2) G (Antenna gain in numeric) =  $10^{(Antenna\ gain\ in\ dBi / 10)}$
- 3) R = distance to the center of radiation of antenna (in meter) = 20cm
- 4) MPE limit = 1mW/cm<sup>2</sup>

For WiFi:

$$2.4GHz\ WiFi: S = \frac{PG}{4R^2\pi} = \frac{36.14 \times 1.000}{4 \times 400 \times 3.14} = 0.007\ mW/cm^2$$

$$5GHz\ WiFi: S = \frac{PG}{4R^2\pi} = \frac{12.59 \times 1.95}{4 \times 400 \times 3.14} = 0.005\ mW/cm^2$$

For BT

The Max Conducted Peak Output Power is 6.79mW

The best case gain of the antenna is 2dBi. 2dB logarithmic terms convert to numeric result is nearly 1.58

$$So, S = \frac{PG}{4R^2\pi} = \frac{6.79 \times 1.58}{4 \times 400 \times 3.14} = 0.002\ mW/cm^2$$

The BT and the 2.4GWiFi modules can simultaneous transmitting. But the maximum rate of MPE is  $\frac{0.002}{1.0} + \frac{0.007}{1.0} = 0.009 \leq 1.0$ .

The BT and the 5GWiFi modules can simultaneous transmitting. But the maximum rate of MPE is  $\frac{0.002}{1.0} + \frac{0.005}{1.0} = 0.007 \leq 1.0$

according to the KDB447498 section 7.2 determine the device is exclusion from SAR test.



**For IC:**

For BT:

$$E.I.R.P.= P*G= 0.00679 \times 1.58=0.011W < 2.68W$$

For 2.4GHz WiFi:

$$E.I.R.P.= P*G= 0.03614 \times 1.00=0.036W < 2.68W$$

For 5GHz WiFi:

$$E.I.R.P.= P*G= 0.01259 \times 1.95=0.025W < 4.5W$$

BT and 2.4G WiFi modules can simultaneous transmitting, so the maximum rate of MPE is  $0.011+0.036=0.047W < 2.68W$

BT and 5G WiFi modules can simultaneous transmitting, so the maximum rate of MPE is  $0.011+0.025=0.036W < 2.68W$

So,the device is exclusion from SAR test.
