## 5.2 MPE Calculation

For FCC:

According to the formula  $S = \frac{PG}{4R^2\pi}$ , we can calculate S which is MPE.

Note:

- 1) P (Watts)
- 2) G (Antenna gain in numeric)
- 3) R = distance to the center of radiation of antenna (in meter) = 20cm
- 4) MPE limit = 1mW/cm<sup>2</sup>

The max conducted output power is 31.2 mW .

The best case gain of the antenna 2 dBi. 2dB logarithmic terms convert to numeric result is nearly 1.58 .

$$\text{So, } S = \frac{PG}{4R^2\pi} = 0.01 \text{ mW/cm}^2 < 1\text{mW/cm}^2$$

So the device is exclusion from SAR test.
