





### **Test Procedure:**

- 1) The mains terminal disturbance voltage was measured with the EUT in a shielded room.
- 2) The EUT was connected to AC power source through a LISN 1 (Line Impedance Stabilization Network) which provides 50Ω/50µH + 5Ω linear impedance. The power cables of all other units of the EUT were connected to a second LISN, which was bonded to the ground reference plane in the same way as the LISN for the unit being measured. 


Figure3. Above 1GHz radiated emissions test configuration


