2.2 Test Mode



2.6 Measurement Results Explanation Example

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 4.2 dB and 10dB attenuator.







6 dB Bandwidth Plot on Channel 19





6 dB Bandwidth Plot on Channel 39







3.2 Peak Output Power Measurement



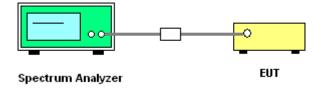

- 5. Detector = peak, Sweep time = auto couple, Trace mode = max hold, Allow trace to fully stabilize. Use the peak marker function to determine the maximum power level.
- 6. Measure and record the results in the test report.
- 7. The Measured power density (dBm)/ 100kHz is a reference level and used as 20dBc down limit line for Conducted Band Edges and Conducted Spurious Emission.




3.3.6 Test Result of Power Spectral Density Plots (100kHz)

PSD 100kHz Plot on Channel 19






PSD 100kHz Plot on Channel 39





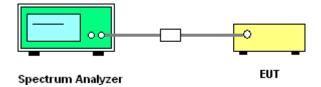

Unwanted Emissions measured in any 100 kHz bandwidth outside of the authorized frequency band shall be attenuated by at least 20 dB relative to the maximum in-band peak PSD level in 100 kHz when maximum peak conducted output power procedure is used. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.

- 6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.

3.5 Radiated Band Edges and Spurious Emission Measurement

3.5.1 Limit of Radiated Band Edges and Spurious Emission

In any 100 kHz bandwidth outside the intentional radiator frequency band, all harmonics/spurious must be at least 20 dB below the highest emission level within the authorized band. 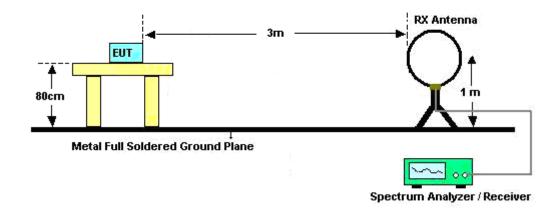



For radiated emissions from 30MHz to 1GHz







3.7 Antenna Requirements

3.7.1 Standard Applicable

If directional gain of transmitting antennas is greater than 6dBi, the power shall be reduced by the same level in dB comparing to gain minus 6dBi. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the rule.
