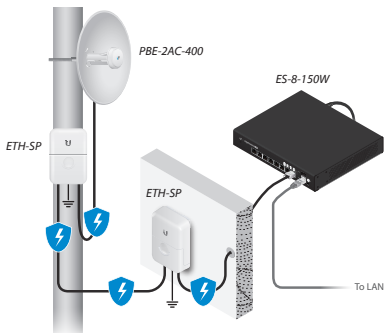
**TERMS OF USE:** Ubiquiti radio devices must be professionally installed. Shielded Ethernet cable and earth grounding must be used as conditions of product warranty. TOUGH Cable™ is designed for outdoor installations. It is the customer's responsibility to follow local country regulations, including operation within legal frequency channels, output power, and Dynamic Frequency Selection (DFS) requirements.

## Installation Requirements

- 13 mm wrench
- Shielded Category 5 (or above) cabling with drain wire should be used for all wired Ethernet connections and should be grounded through the AC ground of the PoE.

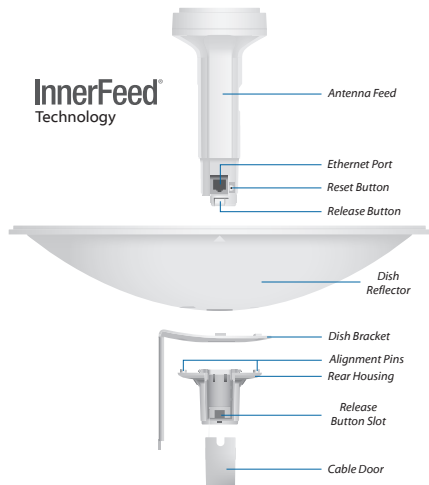
We recommend that you protect your networks from harmful outdoor environments and destructive ESD events with industrial-grade, shielded Ethernet cable from Ubiquiti Networks. For more details, visit [www.ubnt.com/toughcable](http://www.ubnt.com/toughcable)

- Surge protection should be used for all outdoor installations. We recommend that you use two Ethernet Surge Protectors, model ETH-SP, one near the PowerBeam and the other at the entry point to the building. The ETH-SP will absorb power surges and safely discharge them into the ground.



## Hardware Overview

### Bottom View





**Reset Button** To reset to factory defaults, press and hold the *Reset* button for more than 10 seconds while the PowerBeam is already powered on. Alternatively, the PowerBeam may be reset remotely via a *Reset* button located on the bottom of the *Gigabit PoE* adapter.


**Release Button** After you assemble the PowerBeam, check the *Release* button; it should be fully engaged in the *Release Button Slot* of the *Rear Housing*. This ensures that the *Antenna Feed* is locked into place. If you need to remove the *Antenna Feed*, you must depress the *Release* button first.

## LEDs



 **Power** The Power LED will light blue when the device is connected to a power source.

 **Ethernet** The Ethernet LED will light steady blue when an active Ethernet connection is made and flash when there is activity.

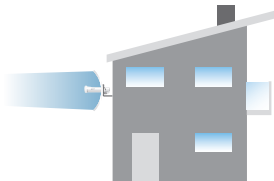
 **Signal** In airOS<sup>®</sup>, you can modify the threshold value for the wireless signal strength LEDs on the *Wireless* tab under *Signal LED Thresholds*. Each LED will light when the wireless signal strength is equal to or greater than the LED's threshold value. The default threshold values for these LEDs are shown below:

-65 dBm   -73 dBm   -80 dBm   -94 dBm

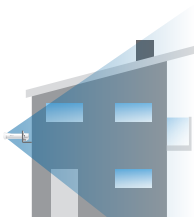


## Application Examples

The PowerBeam mounted outdoors with the *Dish Reflector* installed provides directional outdoor coverage (gain is reflector-dependent).

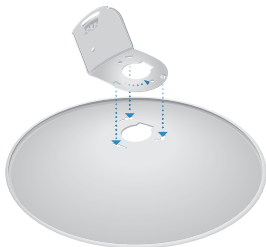


The PowerBeam mounted outdoors without the *Dish Reflector* installed provides outdoor-to-indoor coverage using the 3 dBi *Antenna Feed* only.

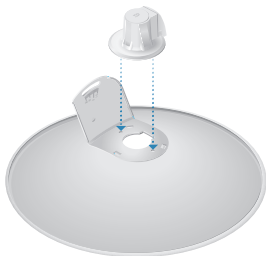


## Installation

1. Align and insert the tabs of the *Dish Bracket* into the slots of the *Dish Reflector*. Rotate the *Dish Bracket* counter-clockwise until the tabs lock into place.



2. Line up the *Alignment Pins* of the *Rear Housing* with the alignment holes of the *Dish Bracket*. Insert the pins and push until they lock into place.

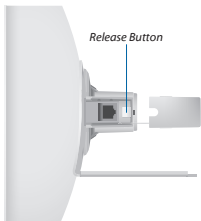
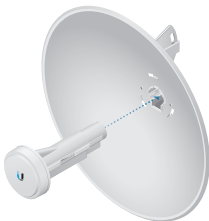


3. Push in the sides of the *Cable Door* and detach it from the *Rear Housing*.



4. Attach the *Antenna Feed*:

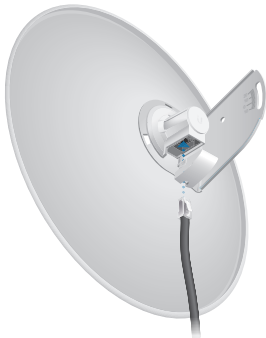
- Insert the *Antenna Feed* into the *Rear Housing*, and push until it locks into place with a click.
- Lightly pull the *Antenna Feed* to ensure that it is locked into place and the *Release* button is fully engaged.



*Bottom View*



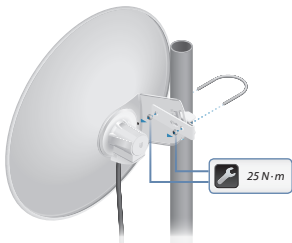
5. Connect the Ethernet cable:
- Connect an Ethernet cable to the *Ethernet Port* of the *Antenna Feed*.
  - Re-attach the *Cable Door* to the *Rear Housing*.



6. Slide the *Pole Clamp* onto the *Dish Bracket*.



7. Insert the *U-Bolt* into the *Pole Clamp* and *Dish Bracket*. Secure each end of the *U-Bolt* with a *Flange Nut*.




**Note:** The mounting assembly can accommodate a  $\varnothing$  32 - 56 mm pole.

8. Optional: If you have the *PowerBeam Radome* (optional accessory), then align the arrows on the bottoms of the *Radome* and *Dish Reflector* so the *Drain Holes* on the *Radome* point downward. Snap the *Radome* onto the *Dish Reflector*.



Connect the power using one of the following options:

- Using the included *Gigabit PoE Adapter*: Go to *Connecting to the PoE Adapter*.
- Using a separate PoE switch: Connect the Ethernet cable from the PowerBeam's *Ethernet* port to a PoE-enabled Ethernet port on the switch.

 **WARNING:** The switch port must comply with the power specifications listed in the *Specifications* section of this Quick Start Guide.

## Connecting to the PoE Adapter

1. Connect the Ethernet cable from the PowerBeam's *Ethernet* port to the **POE** port of the *Gigabit PoE* adapter.
2. Connect an Ethernet cable from your LAN to the adapter's **LAN** port.
3. Connect the *Power Cord* to the adapter's power port. Connect the other end of the *Power Cord* to a power outlet.



## Mounting the PoE Adapter (Optional)

1. Remove the *PoE Mounting Bracket* from the adapter, place the bracket at the desired location, and mark the two holes.
2. Pre-drill the holes if necessary, and secure the bracket using two fasteners (not included).
3. Align the adapter's slots with the tabs of the *PoE Mounting Bracket*, and then slide the adapter down.



## Accessing airOS via Wi-Fi

Verify connectivity in the airOS Configuration Interface. There are two methods, the UMobile App and Web Portal. Both are available for 15 minutes immediately after you power on the PowerBeam. If necessary, you can power cycle the PowerBeam to re-enable its Wi-Fi.

Proceed to the appropriate instructions:

### UMobile App

1. Download the UMobile app from the App Store (iOS) or Google Play™ (Android).

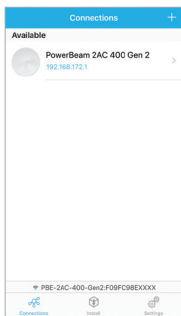


2. Connect your device's Wi-Fi to the PowerBeam SSID named: **PBE-2AC-400:<MAC Address>**




**Note:** Ensure that DHCP is enabled on your Wi-Fi adapter.

4. Tap the PowerBeam on the *Connections* screen




5. Tap **Connect** on the *Login* screen.



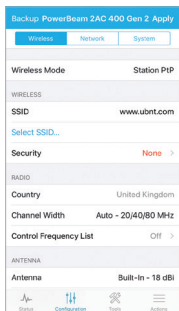

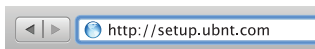

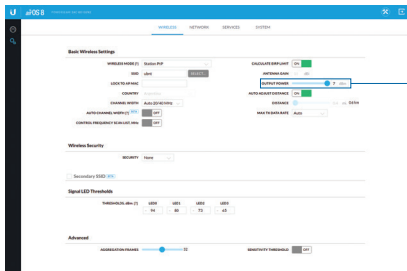
