#### 2.2 Description of EUT

The U6-Mesh is a four-stream WiFi 6 access point that provides up to 2,7 Gbps aggregate radio rate with 5 GHz (MU-MIMO and OFDMA) and 2.4 GHz (MIMO) radios. The U6-Mesh has a sleek design and is intended for indoor or outdoor use. The U6-Mesh has an Ethernet port for data transfer and is powered by a POE-48-24W PoE power adapter.

This report covers the circuitry of the device subject to FCC Part 15, Subpart C. The circuitry of the device subject to FCC Part 15 Subpart B was found to be compliant and is covered under a separate Unified Compliance Laboratory report.




Diagram 1: Test Configuration Block Diagram






Figure 2: Dire	ct Connect at	the Antenna	<b>Port Test</b>




Figure 3: Radiated Emissions Test

## 5.3 §15.247(b)(3) Maximum Average Output Power

The maximum average RF conducted output power measured for this device was 23.4 dBm or 218.78 mW. The limit is 30 dBm or 1 Watt when using antennas with 6 dBi or less gain. The antenna has a gain of 3 dBi.

In the configuration tested, the maximum average RF output power was less than 1 watt; therefore, the EUT complied with the requirements of the specification (see spectrum analyzer plots in the associated annex report).



#### 5.4 §15.247(d) Spurious Emissions

#### 5.4.1 Conducted Spurious Emissions

The frequency range from the lowest frequency generated or used in the device to the tenth harmonic of the highest fundamental frequency was investigated to measure any antenna-conducted emissions. The measurement data from spurious emissions noted across the frequency range when transmitting at the lowest frequency, middle frequency and upper frequency. Shown within the annex are plots with the EUT tuned to the upper and lower channels. These demonstrate compliance with the provisions of this section at the band edges.

The emissions must be attenuated 30 dB below the highest power spectral density level measured within the authorized band as measured with a 100 kHz RBW.

#### Result

Conducted spurious emissions were attenuated 30 dB or more below the fundamental; therefore, the EUT complies with the specification. All results are within the associated annex.

#### 5.4.2 Radiated Spurious Emissions in the Restricted Bands of §15.205

The frequency range from the lowest frequency generated or used in the device to the tenth harmonic of the highest fundamental emissions was investigated to measure any radiated emissions in the restricted bands. The following tables show measurements of any emissions that fell into the restricted bands of \$15.205. The tables show the worst-case emissions measured from the EUT. For frequencies above 18.0 GHz, a measurement distance of 1 meter was used. The noise floor was a minimum of 6 dB below the limits. The emissions in the restricted bands must meet the limits specified in \$15.209. Tabular data for each of the spurious emissions is shown below for each of the units. Plots of the worst-case band edges are also shown.








Graph 2: Radiated Upper Band Edge Plot 20 MHz
