Remark:	

- 1. The maximum conducted output power is <u>10.14dBm (10.328mW)</u> at <u>2480MHz</u> (with <u>2.6dBi</u> <u>antenna gain</u>.)
- DTS device is not subject to routine RF evaluation; MPE estimate is used to justify the compliance.
- For mobile or fixed location transmitters, no SAR consideration applied. The maximum power density is 1.0 mW/cm² even if the calculation indicates that the power density would be larger.

No non-compliance noted.

12.4 Calculation

Given $E = \frac{\sqrt{30 \times P \times G}}{d}$ & $S = \frac{E^2}{3770}$

Where E = Field strength in Volts / meter

P = Power in Watts G = Numeric antenna gain

d = *Distance in meters*

S = Power density in milliwatts / square centimeter

Combining equations and re-arranging the terms to express the distance as a function of the remaining variables yields:

Equation 1

$$S = \frac{30 \times P \times G}{3770d^2}$$

Changing to units of mW and cm, using:

P (*mW*) = *P* (*W*) / 1000 and *d* (*cm*) = *d*(*m*) / 100 Yields

$$S = \frac{30 \times (P/1000) \times G}{3770 \times (d/100)^2} = 0.0796 \times \frac{P \times G}{d^2}$$

Where d = Distance in cm P = Power in mW G = Numeric antenna gain S = Power density in mW / cm²
