Hardware Overview



1 Camera

Built-in camera can be used for snapping photos for avatars or videoconferencing applications.

2 Touchscreen


The touchscreen display is used for all interface navigation and dialing.

3 Keypad

Touch to display the numeric keypad.

4 LED

The LED will illuminate when the device is first connected to a 48V power source. Once the phone has started up, the LED will turn off.

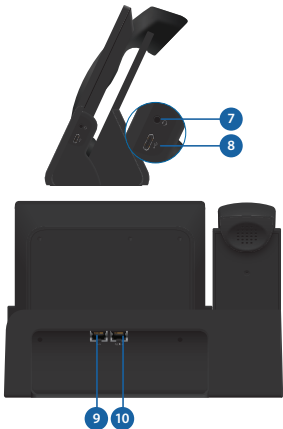
 **IMPORTANT:** The LED will flash when a firmware update is occurring. Do not disconnect power/Ethernet from the device during this time.

5 Volume

Press this soft button to display the volume adjustment screen.

6 Mute Button

Press this button to mute the phone's audio output.



7 Headset Jack

3.5 mm jack for optional wired stereo and microphone headsets.

8 USB C Port

The USB C port can be used to charge a device.

9 PC

This Ethernet port is used for bridging.



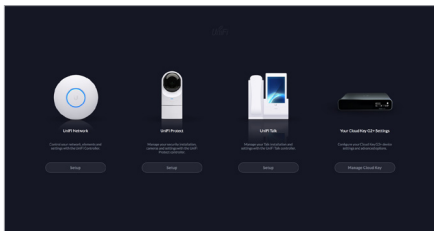

10 PoE/LAN

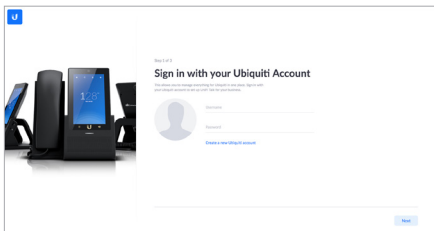
