

13. FREQUENCY SEPARATION

13.1. MEASUREMENT PROCEDURE

The EUT shall have its hopping function enabled. Use the following spectrum analyzer settings:

- 1. Span: Wide enough to capture the peaks of two adjacent channels.
- 2. RBW: Start with the RBW set to approximately 30% of the channel spacing; adjust as necessary to best identify the center of each individual channel.
- 3. Video (or average) bandwidth (VBW) ≥ RBW.
- 4. Sweep: Auto. e) Detector function: Peak. f) Trace: Max hold. g) Allow the trace to stabilize.

Use the marker-delta function to determine the separation between the peaks of the adjacent channels.

TEST PLOT FOR FREQUENCY SEPARATION






RADIATED EMISSION TEST SETUP BELOW 1GHz



RADIATED EMISSION TEST SETUP ABOVE 1GHz








CONDUCTED EMISSION TEST SETUP





BOTTOM VIEW OF EUT




