



- Press 4H: 4 hrs on 20 hrs off.
- Press 6H: 6 hrs on 18 hrs off.
- Press 8H: 8 hrs on 16 hrs off.

NOTE: String light will cycle with set hours until it is reset. To reset, disconnect plug from power outlet and plug back into power outlet.

BATTERY WARNING:
