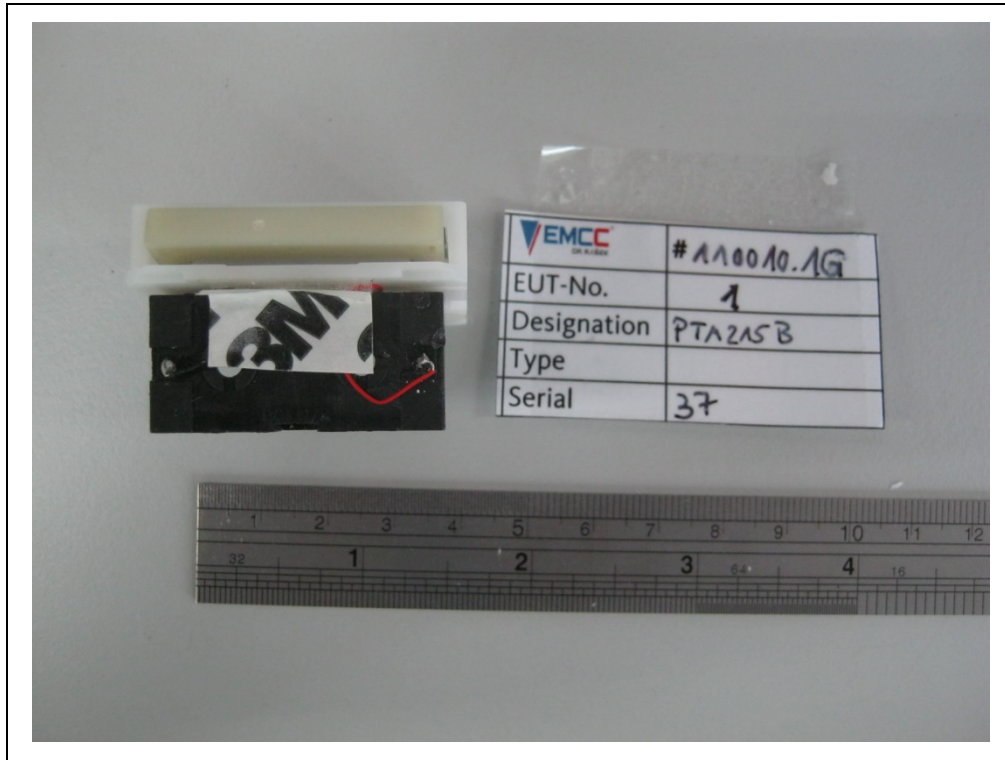


Photograph A2-3: EUT#1 back, with battery housing used for test

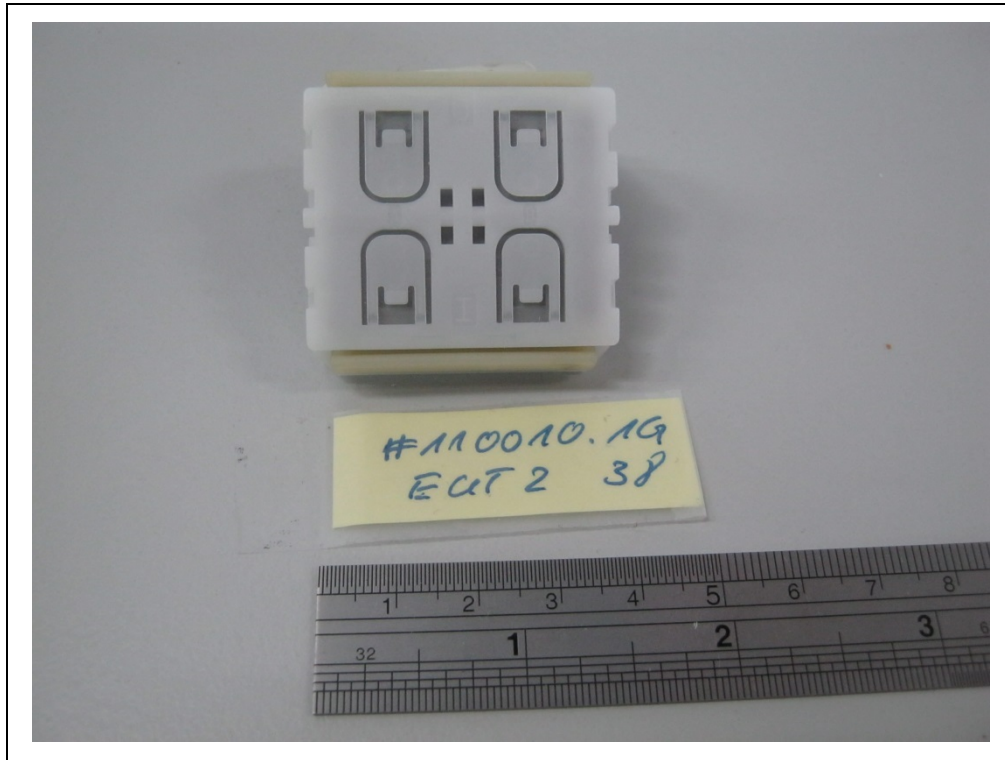


Photograph A2-5: EUT#1 side 3, with battery housing used for test

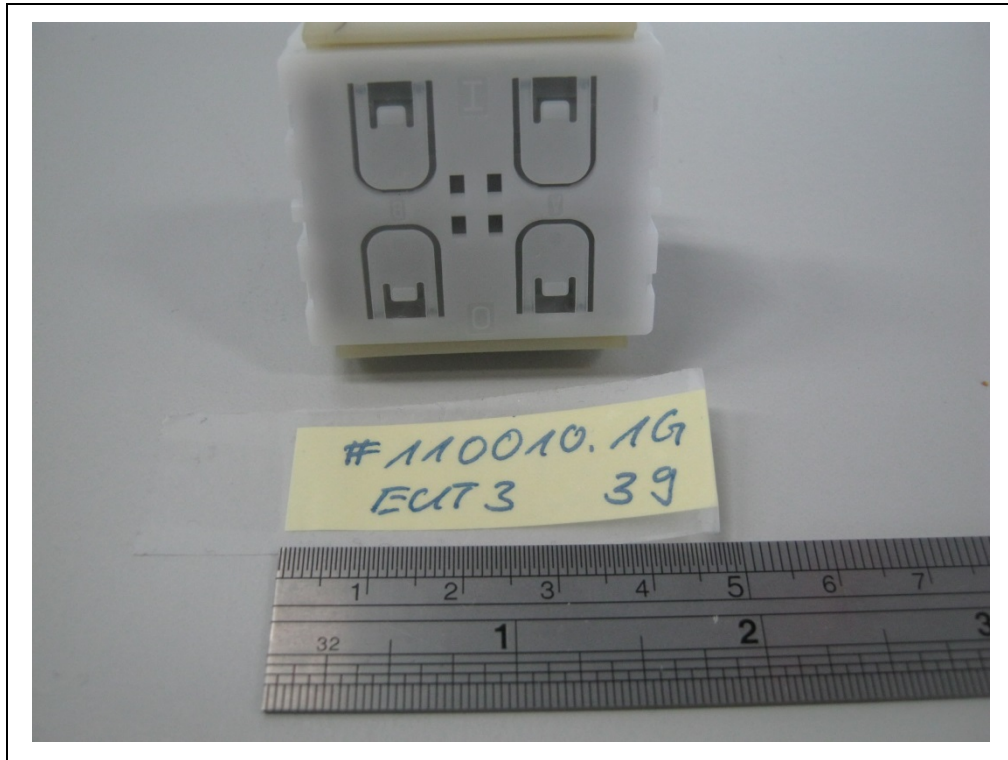
