



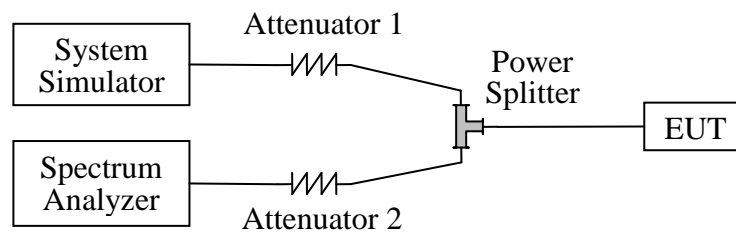
3.1. Conducted RF Output Power

3.1.1 Requirement

According to FCC section 2.1046(a), for transmitters other than single sideband, independent sideband and controlled carrier radiotelephone, power output shall be measured at the RF output terminals when the transmitter is adjusted in accordance with the tune-up procedure to give the values of current and voltage on the circuit elements specified in FCC section 2.1033(c)(8).

3.1.2 Test Description

1. Test Setup:



The EUT, which is powered by the Battery, is coupled to the Spectrum Analyzer (SA) and the System Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 50Ohm; the path loss as the factor is calibrated to correct the reading. The EUT is commanded by the SS to operate at the maximum output power i.e. Power Control Level (PCL) = 5 and Power Class = 4. A call is established between the EUT and the SS.

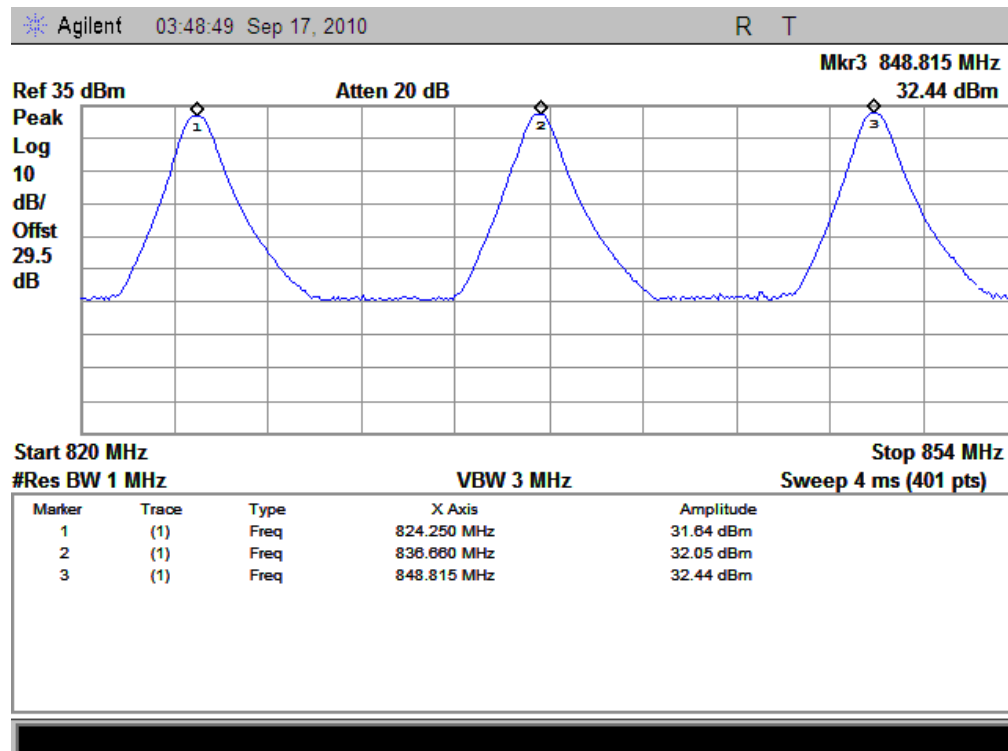
3.1.3 Test Result

Here the lowest, middle and highest channels are selected to perform testing to verify the conducted RF output power of the EUT. For the GSM 850MHz operates at PCL=5 (where Power Class is 4), the rated conducted RF output power is 33dBm within the tolerance of ± 3 dB, and For the GSM 1900MHz operates at PCL=0 (where Power Class is 1), the rated conducted RF output power is 30dBm within the tolerance of ± 3 dB.

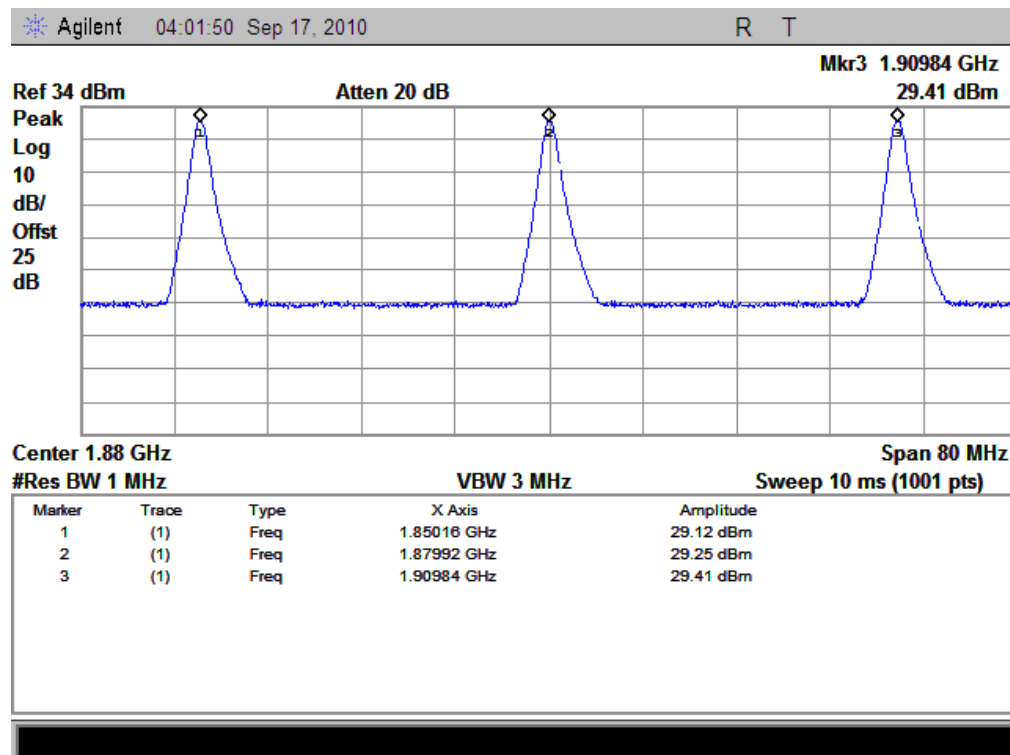

3.2 99% Occupied Bandwidth

3.2.1 Definition

According to FCC section 2.1049, the occupied bandwidth is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers radiated are each equal to 0.5 percent of the total mean power radiated by a given emission.

Occupied bandwidth is also known as the 99% emission bandwidth,.

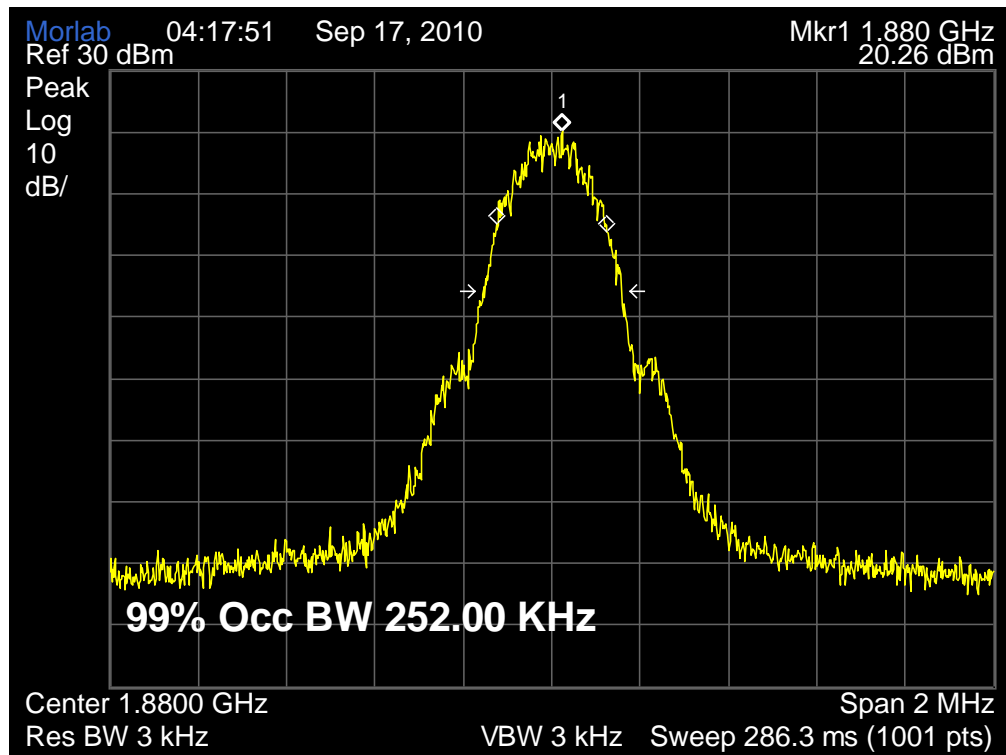
(Plot B: GSM 850MHz Channel = 190)



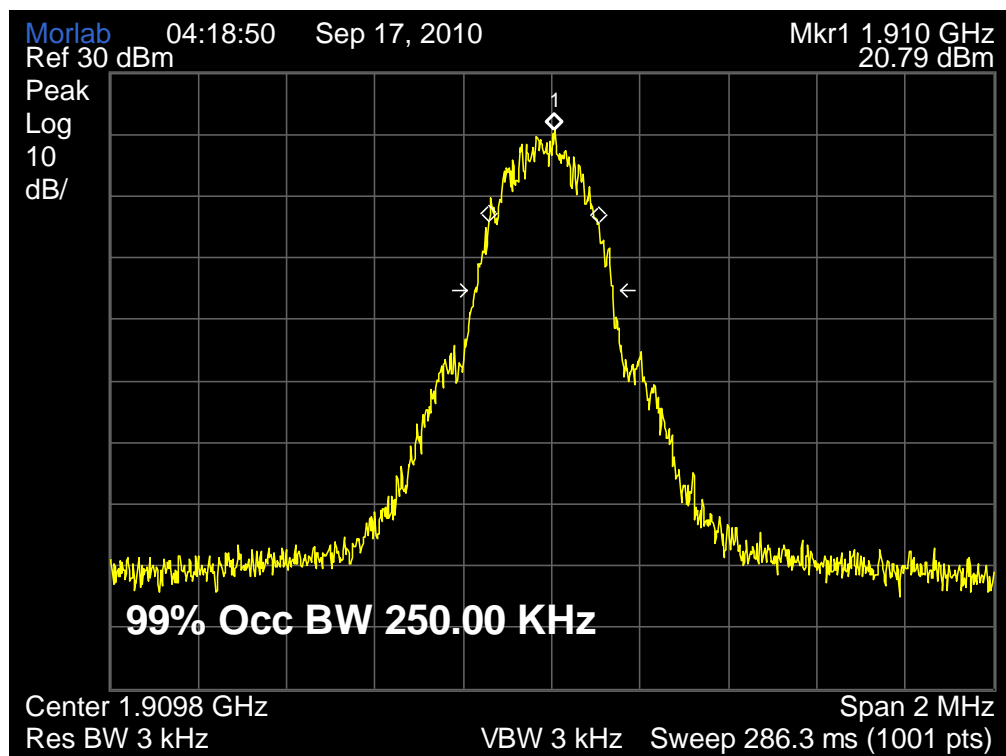
(Plot C: GSM 850MHz Channel = 251)

3.3 Frequency Stability

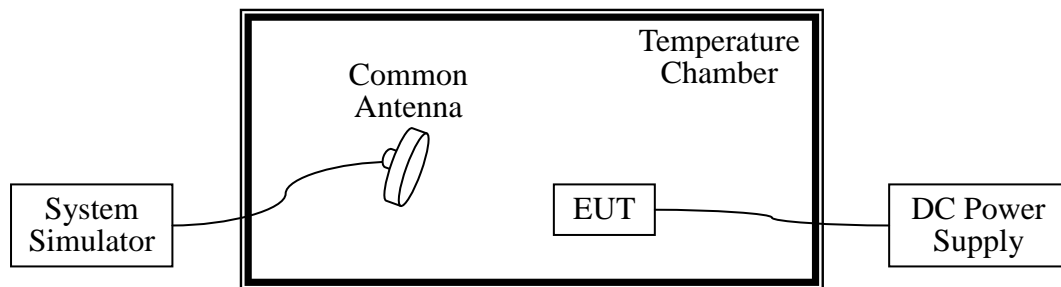
3.3.1 Requirement

According to FCC section 22.355 and FCC section 24.235, the frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block. According to FCC section 2.1055, the test conditions are:

- The temperature is varied from -30 °C to +50 °C at intervals of not more than 10 °C.
- For hand carried battery powered equipment, the primary supply voltage is reduced to the battery operating end point which shall be specified by the manufacture. The supply voltage shall be measured at the input to the cable normally provided with the equipment, or at the power supply terminals if cables are not normally provided.

3.3.2 Test Description

1. Test Setup:



The EUT, which is powered by the DC Power Supply directly, is located in the Temperature Chamber. The EUT is commanded by the System Simulator (SS) to operate at the maximum output power i.e. Power Control Level (PCL) = 5 and Power Class = 4. A call is established between the EUT and the SS via a Common Antenna.

3.4 Conducted Out of Band Emissions

3.4.1 Requirement

According to FCC section 22.917(a) and FCC section 24.238(a), the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least $43+10*\log(P)$ dB. This calculated to be -13dBm.

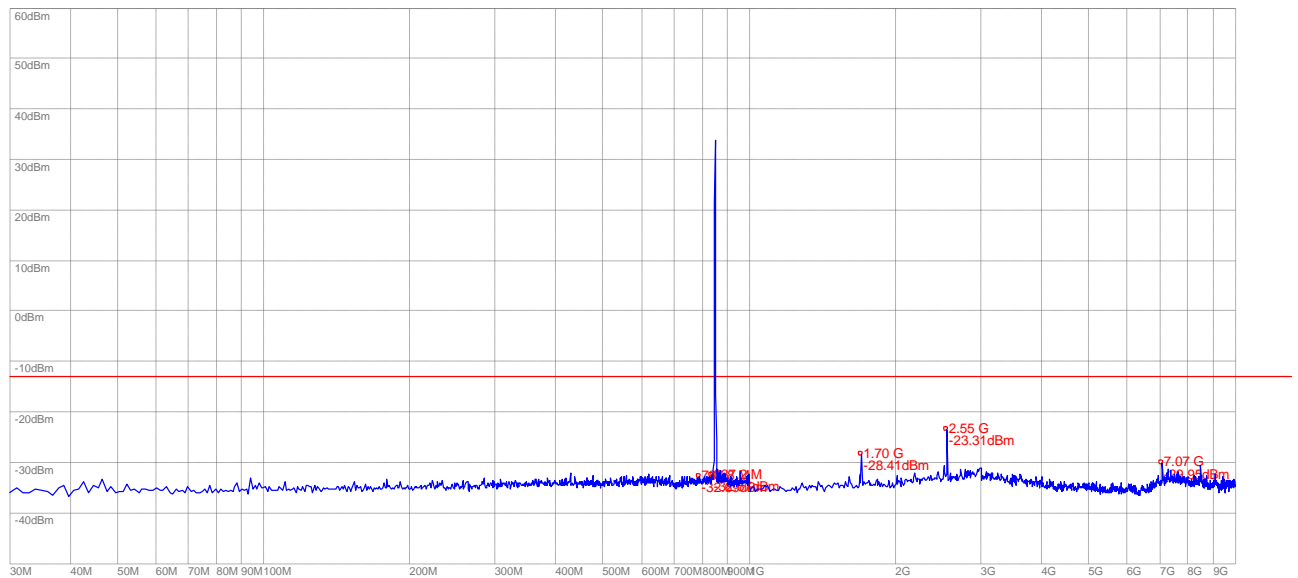

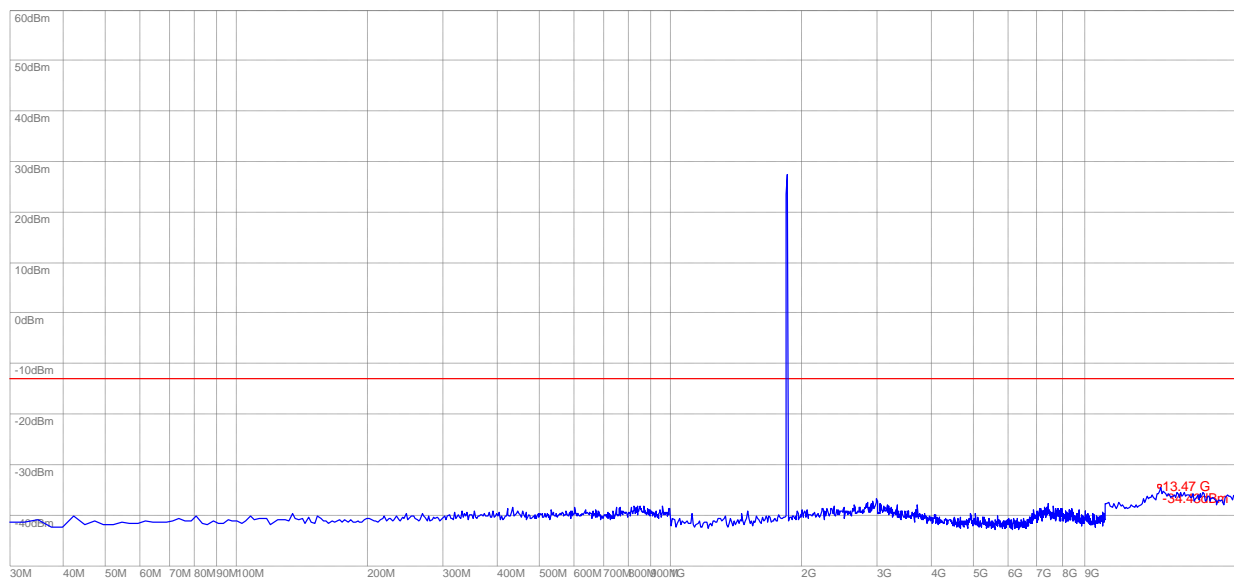
(Plot A: GSM 850MHz Channel = 128, 30MHz to 10GHz)



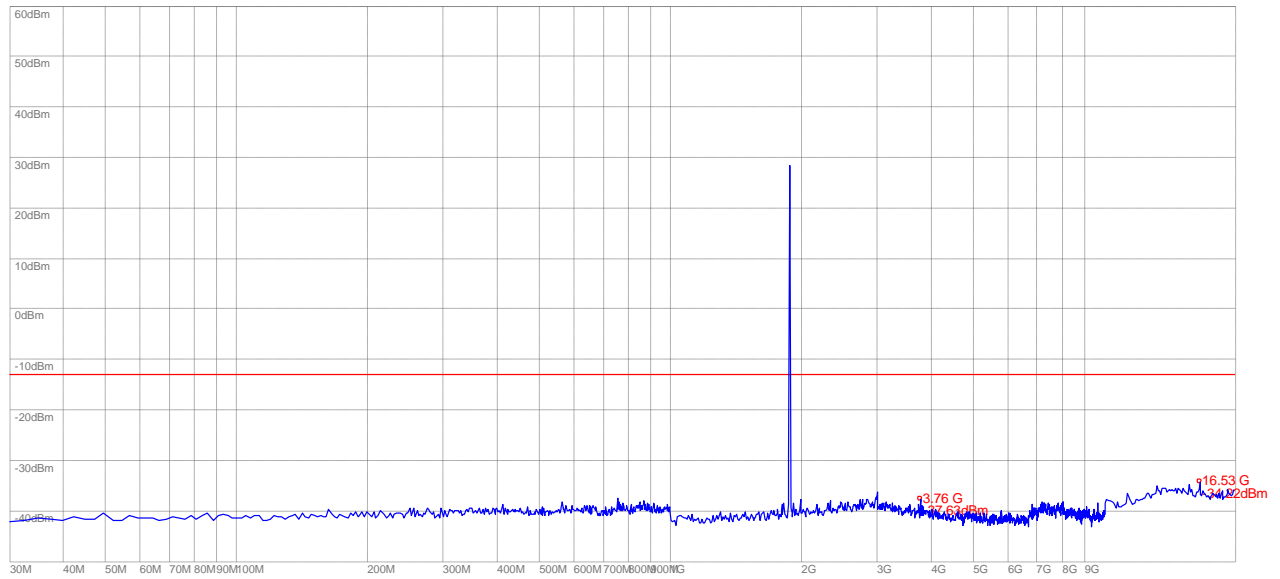
(Plot B: GSM 850MHz Channel = 190, 30MHz to 10GHz)



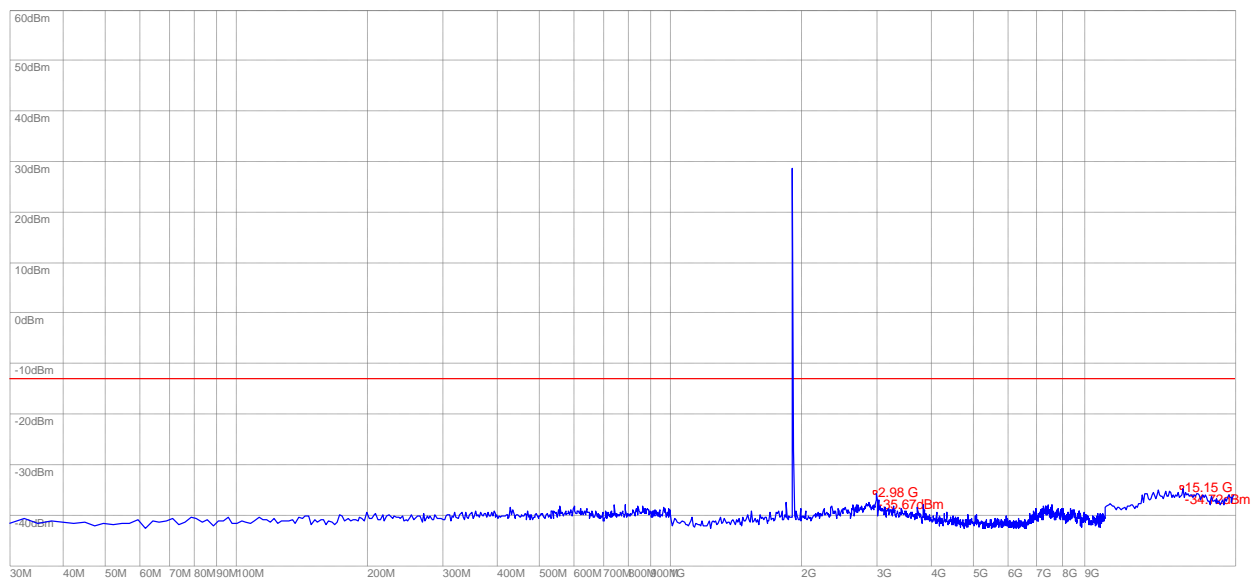

3.5 Band Edge

3.5.1 Requirement

According to FCC section 22.917(b) and FCC section 24.238(b), in the 1MHz bands immediately outside and adjacent to the frequency block a resolution bandwidth of at least one percent of the emission bandwidth (26dB emission bandwidth) of the fundamental emission of the transmitter may be employed.

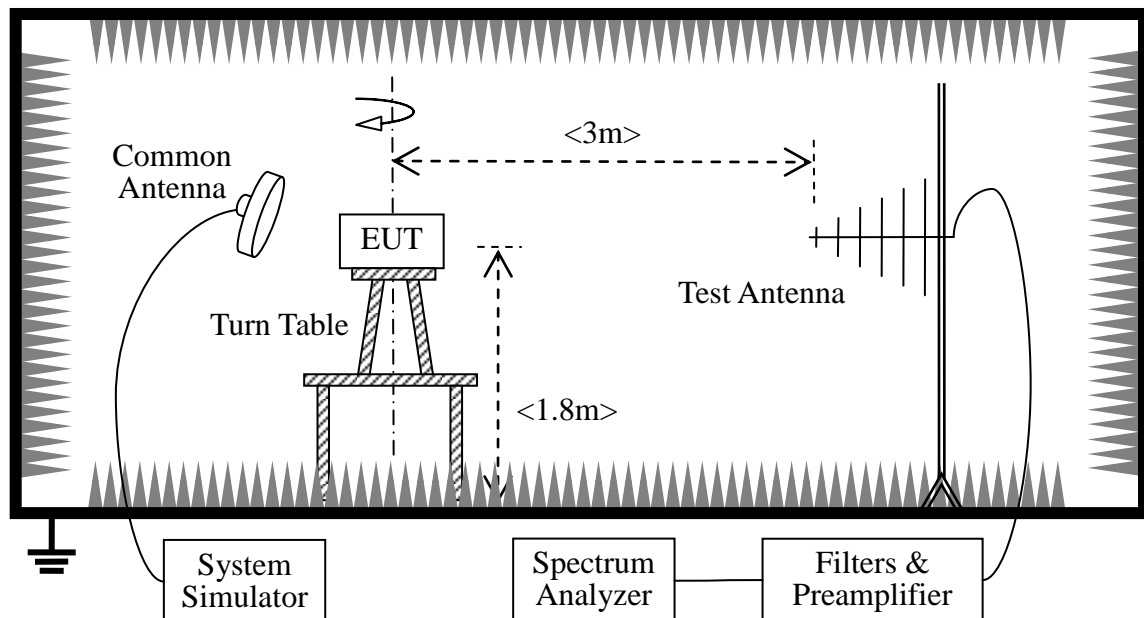
3.6 Transmitter Radiated Power (EIRP/ERP)

3.6.1 Requirement

According to FCC section 22.913, the Effective Radiated Power (ERP) of mobile transmitters and auxiliary test transmitters must not exceed 7Watts, and FCC section 24.232, the broadband PCS mobile station is limited to 2Watts e.i.r.p. peak power.

3.6.2 Test Description

1. Test Setup:



The EUT, which is powered by the Battery charged with the AC Adapter, is located in a 3m Full-Anechoic Chamber; the cable loss, air loss and so on of the site as factors are pre-calibrated using the "Substitution" method, and calculated to correct the reading.

A call is established between the EUT and the SS via a Common Antenna. The EUT is commanded by the SS to operate at the maximum and minimum output power (i.e. GSM850MHz band Power Control Level (PCL) = 5/19 and Power Class = 4, GSM1900MHz band Power Control Level (PCL) = 0/15 and Power Class = 1), and only the test result of the maximum output power was recorded.

-Maximum RF output power: GSM850 32.44dBm, GSM 1900 29.41dBm, Please refer to section 3.1.3 of this report.

- Step size (dB): 3dB

- Minimum RF power: GSM850 5.84dBm, GSM 1900 1.14dBm

The Test Antenna is a Bi-Log one (used for 30MHz to 1GHz) or a Horn one (used for above 3GHz), and it's located at the same height as the EUT. The Filters consists of Notch Filters and High Pass Filter.

3.6.3 Test Result

The Turn Table is actuated to turn from 0 ° to 360 °, and both horizontal and vertical polarizations of the Test Antenna are used to find the maximum radiated power. The lowest, middle and highest channels are tested.

The substitution corrections are obtained as described below:

$$A_{\text{SUBST}} = P_{\text{SUBST_TX}} - P_{\text{SUBST_RX}} - L_{\text{SUBST_CABLES}} + G_{\text{SUBST_TX_ANT}}$$

$$A_{\text{TOT}} = L_{\text{CABLES}} + A_{\text{SUBST}}$$

Where A_{SUBST} is the final substitution correction including receive antenna gain.

$P_{\text{SUBST_TX}}$ is signal generator level,

$P_{\text{SUBST_RX}}$ is receiver level,

$L_{\text{SUBST_CABLES}}$ is cable losses including TX cable,

$G_{\text{SUBST_TX_ANT}}$ is substitution antenna gain.

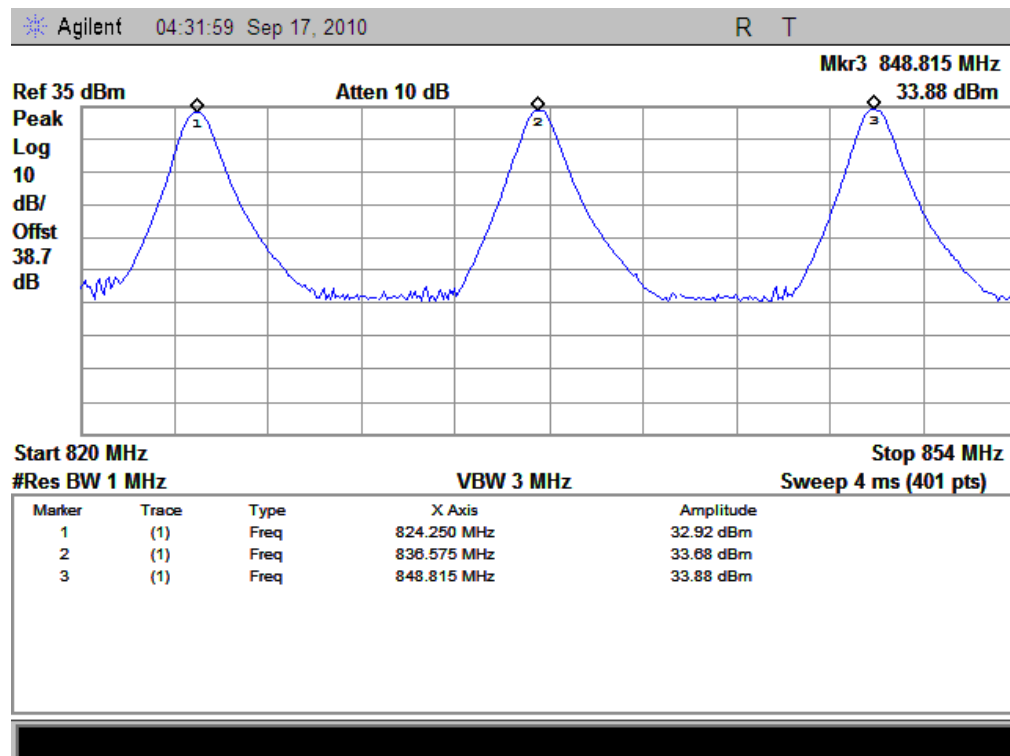

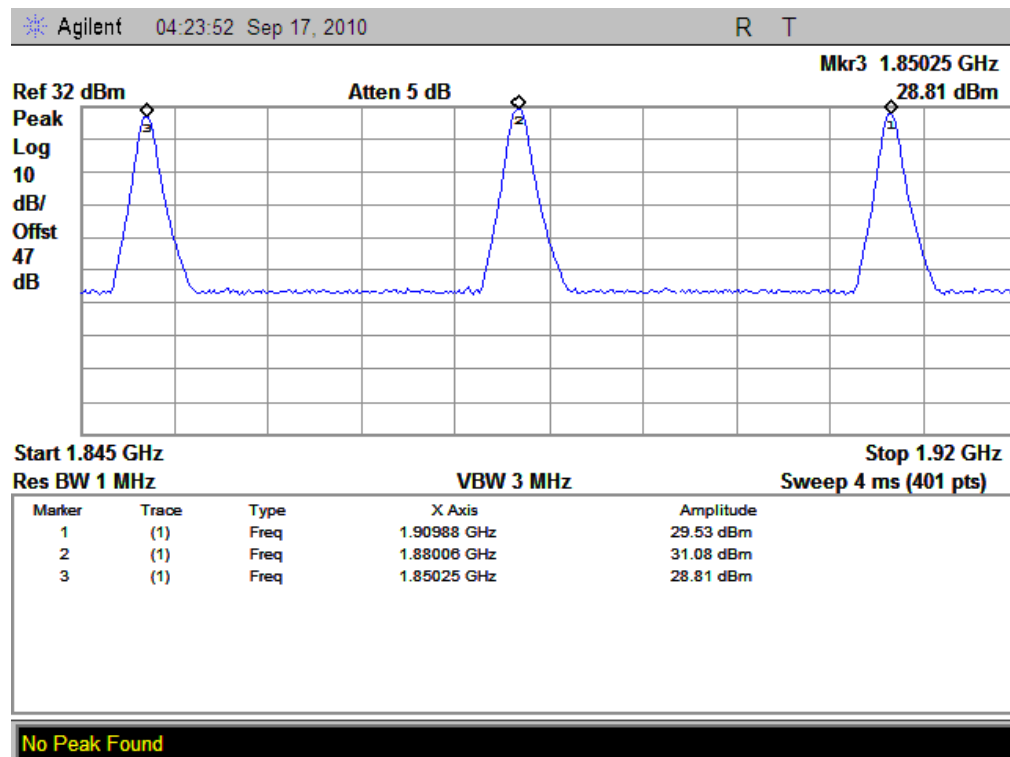

Note: when doing measurements above 1GHz, the EUT has been within the 3dB cone width of the horn antenna during horizontal antenna.

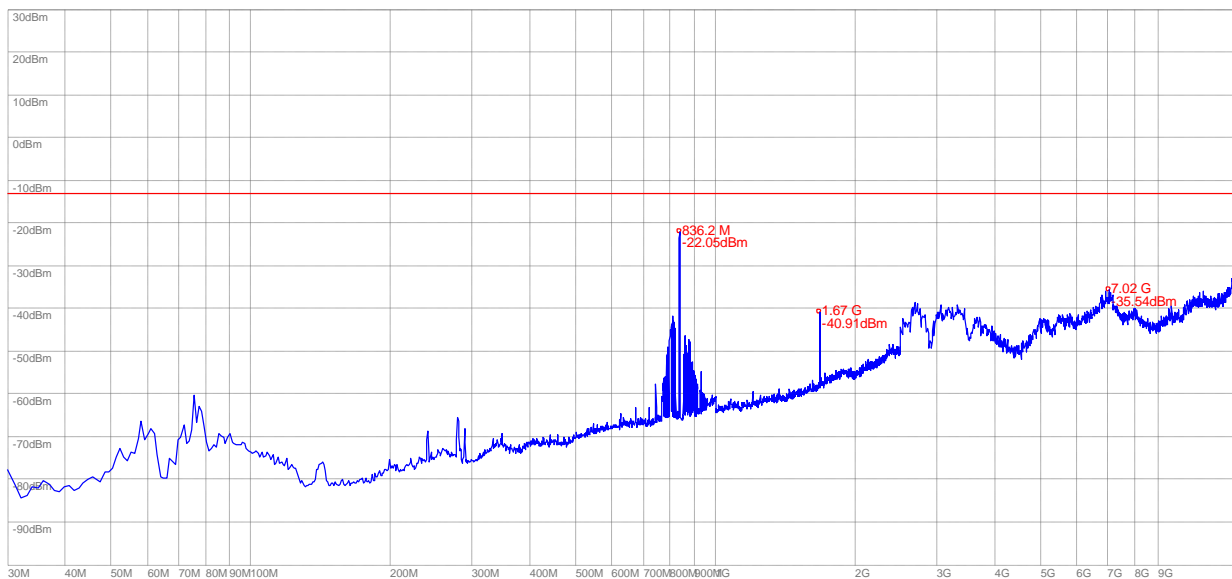
(Plot A.1: GSM 850MHz Channel = 128, Test Antenna Horizontal)



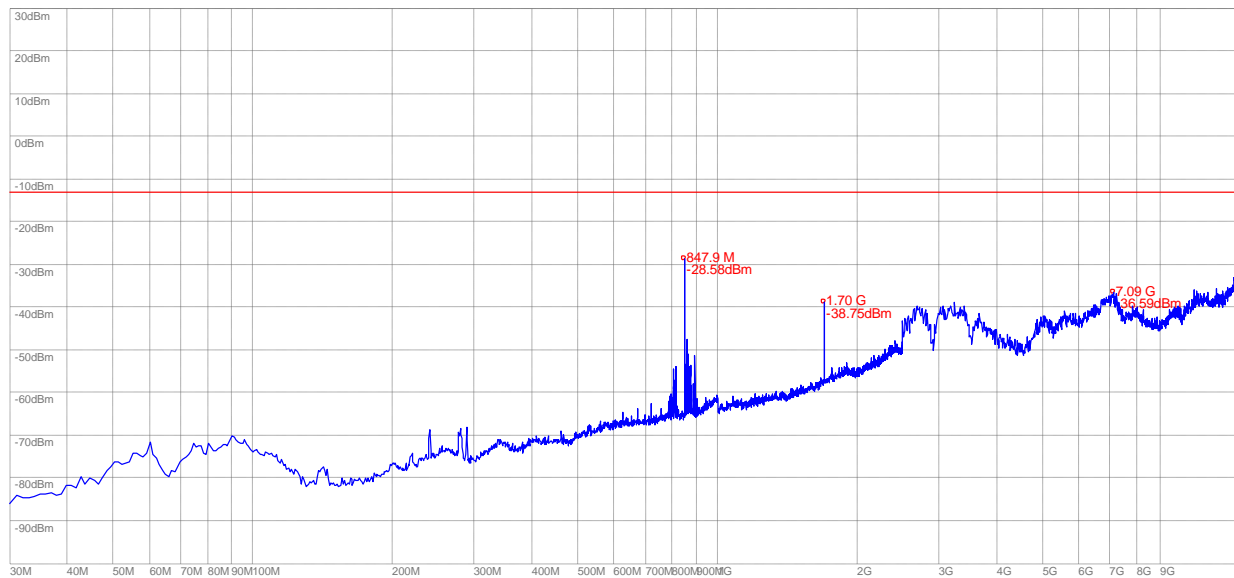
(Plot A.2: GSM 850MHz Channel = 128, Test Antenna Vertical)



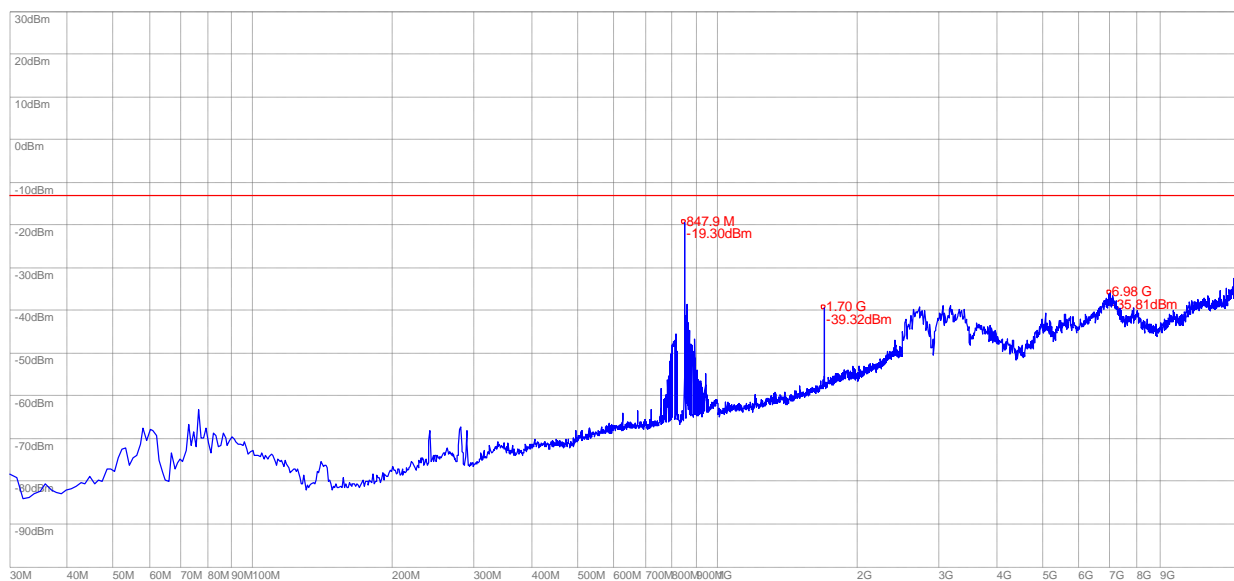
