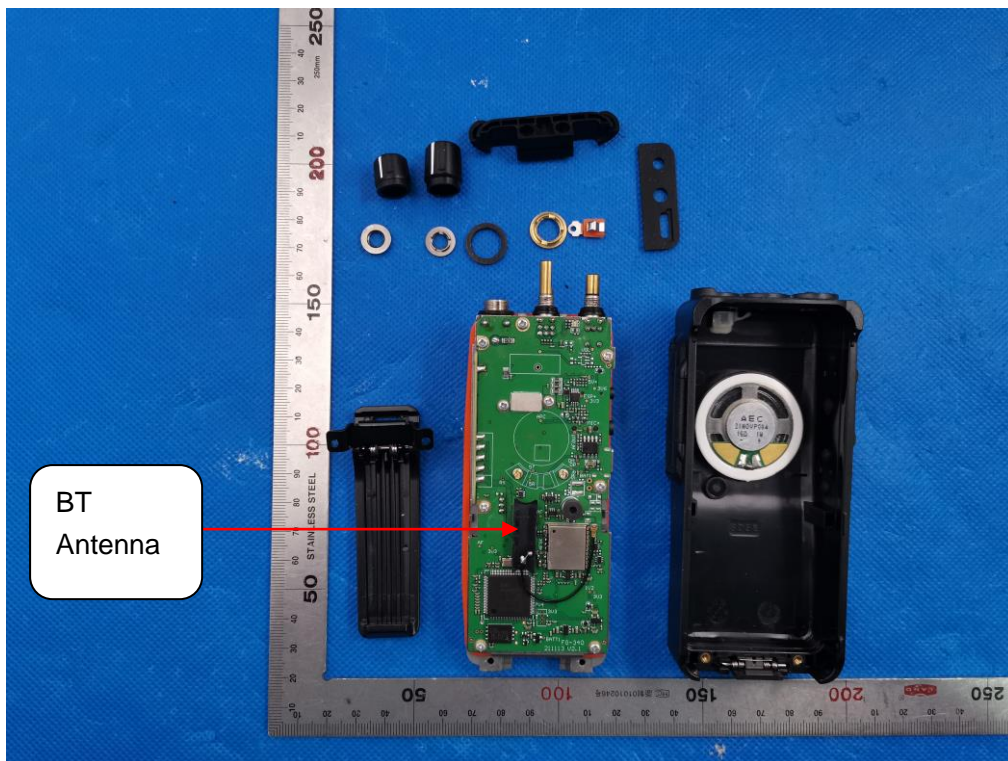

### OPEN VIEW OF EUT(FIGURE 1)

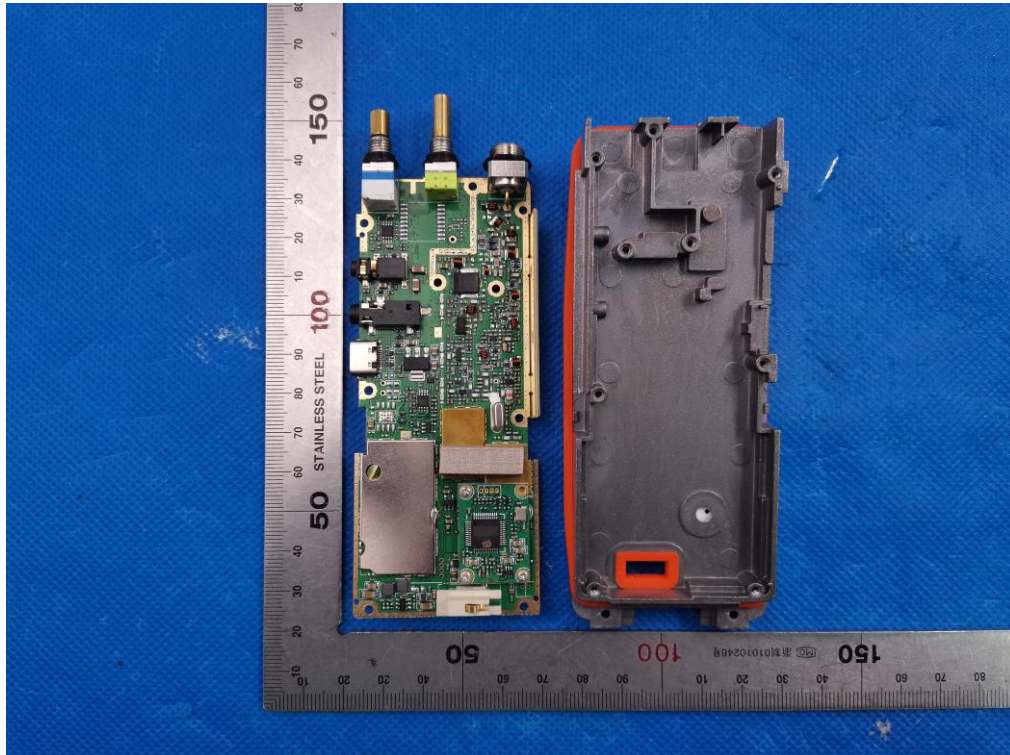


### OPEN VIEW OF EUT(FIGURE 2)

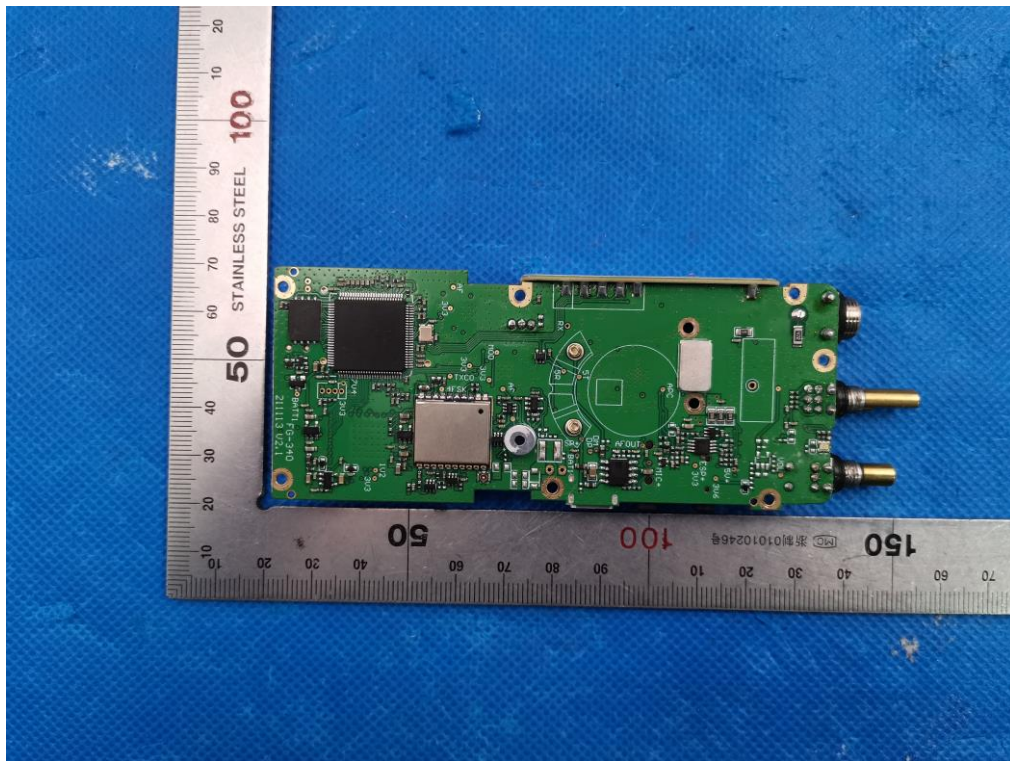

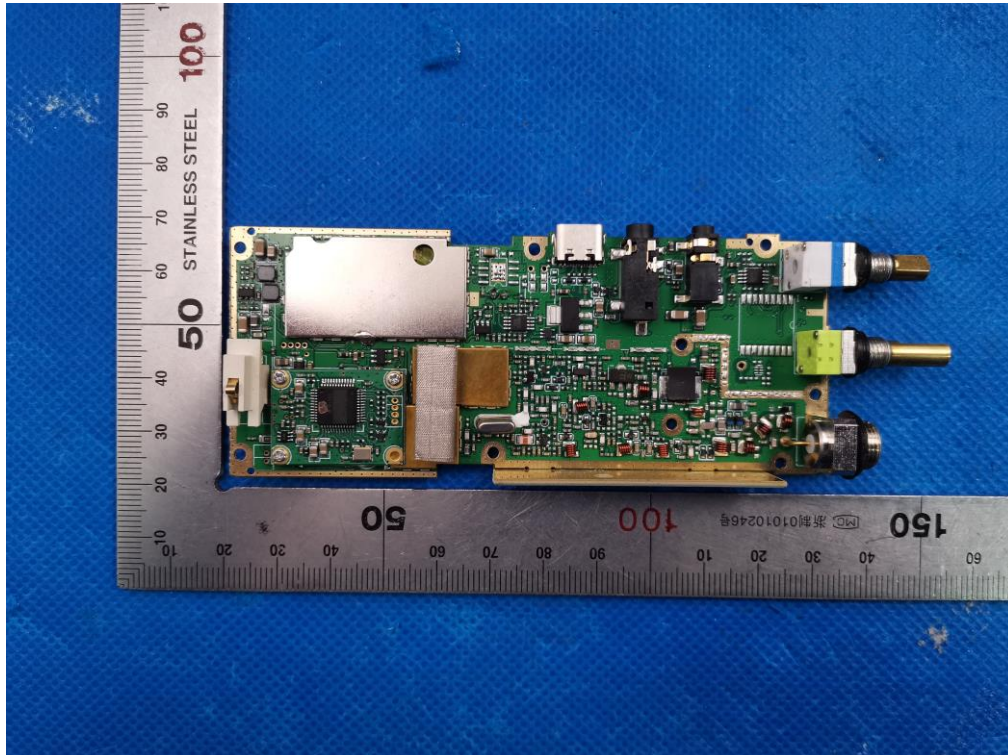

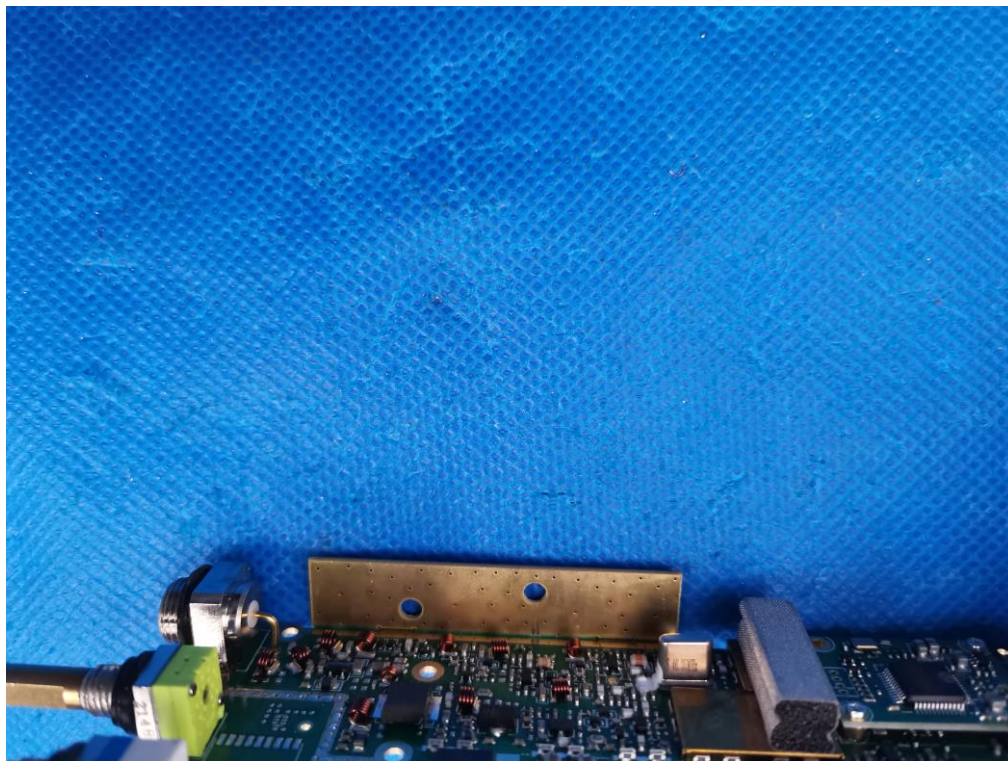

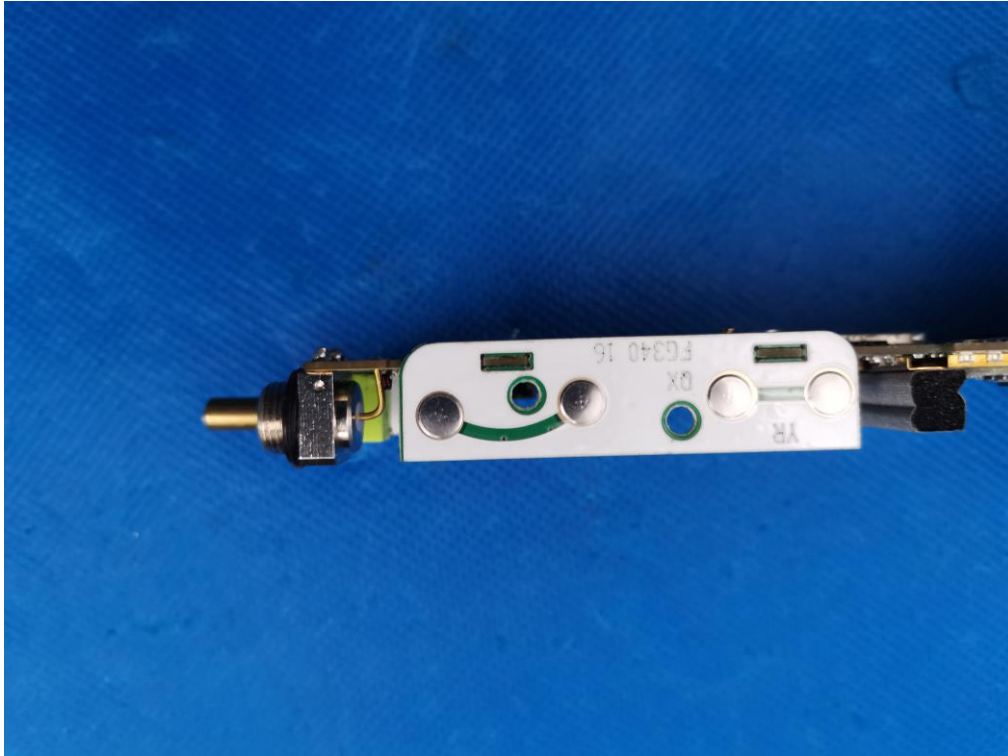

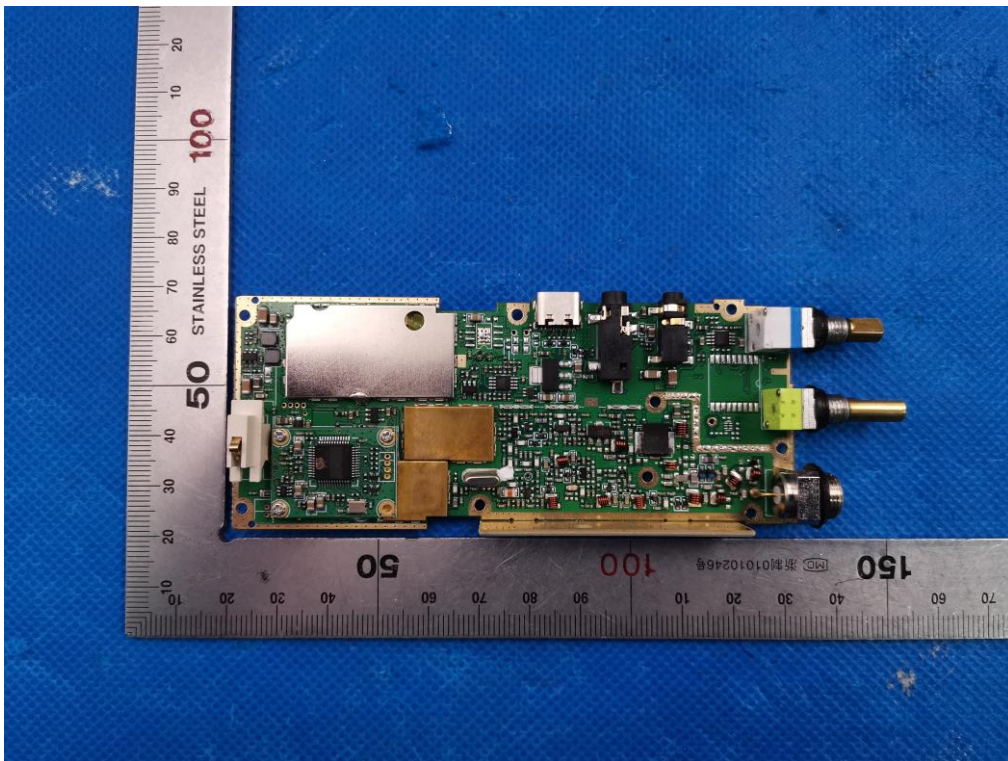

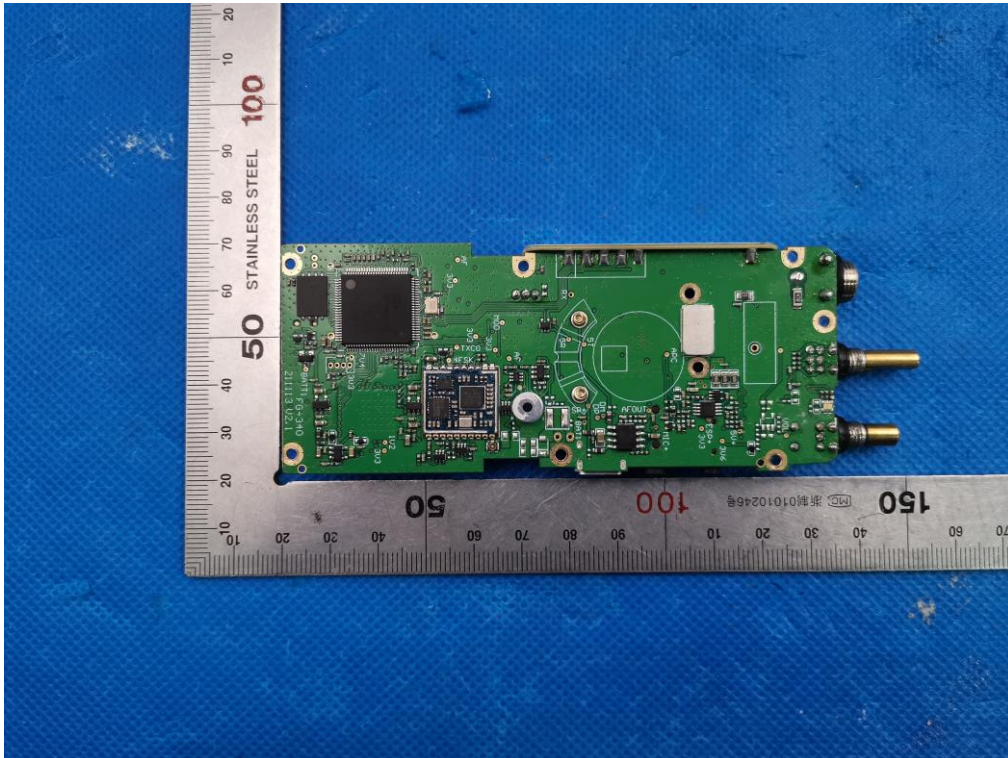

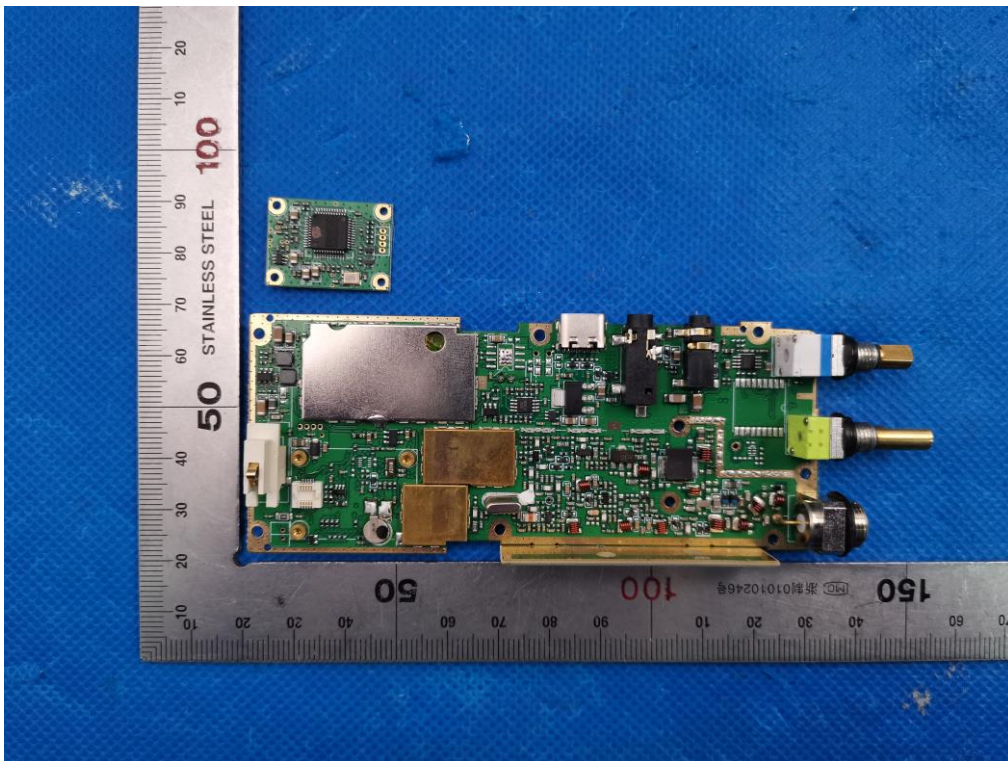

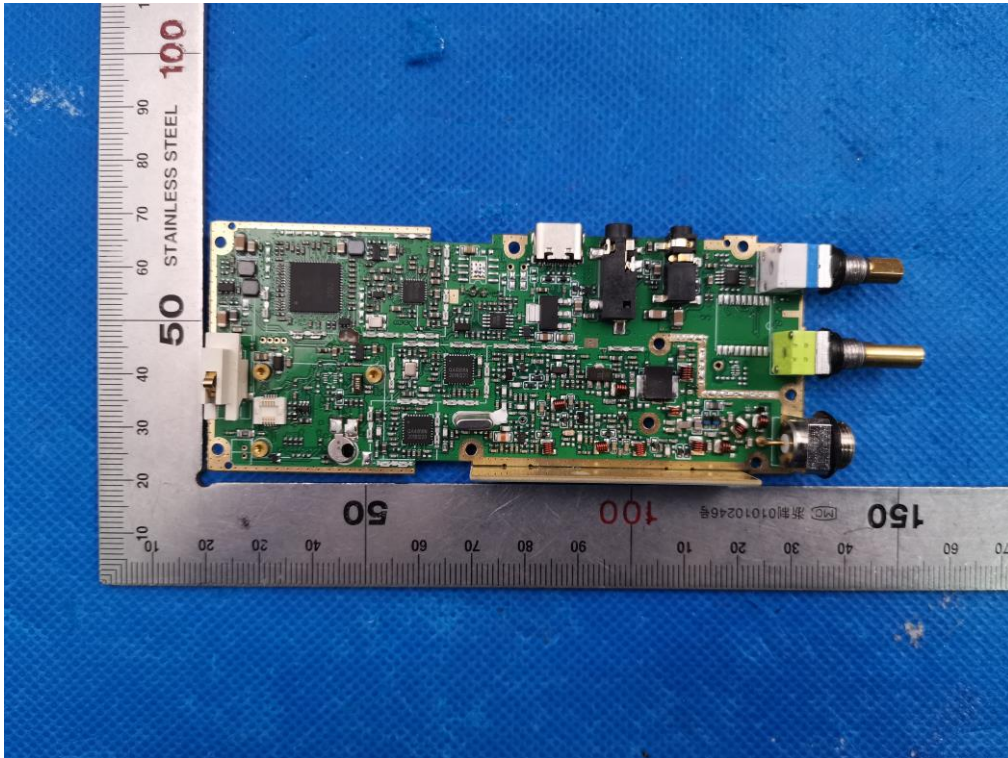

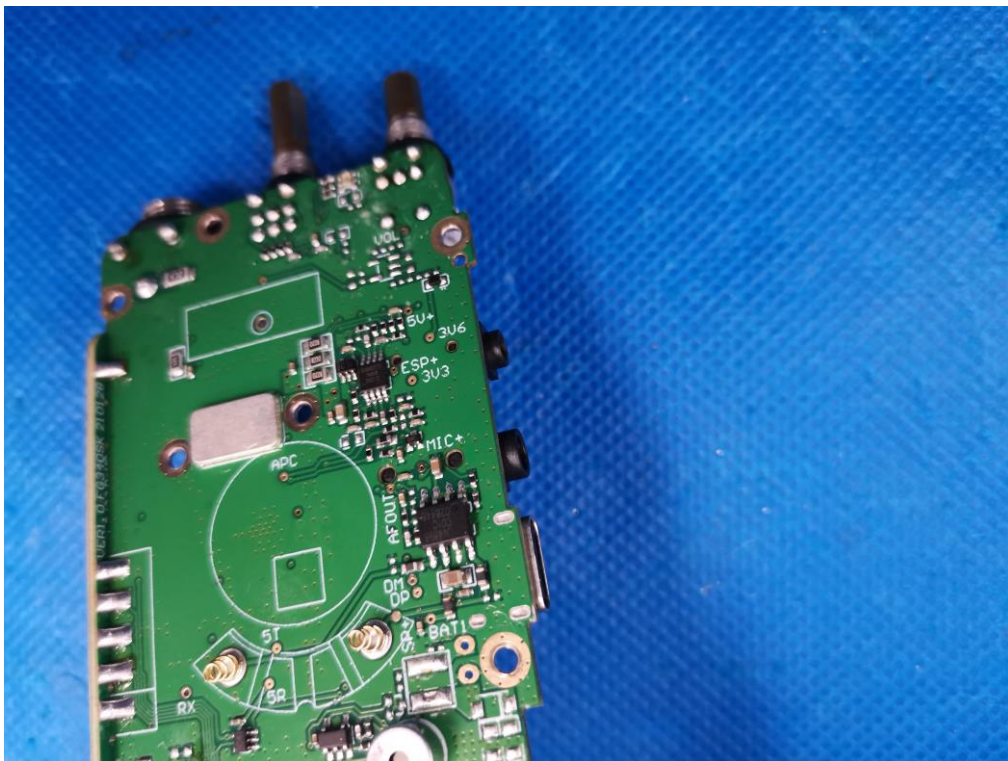

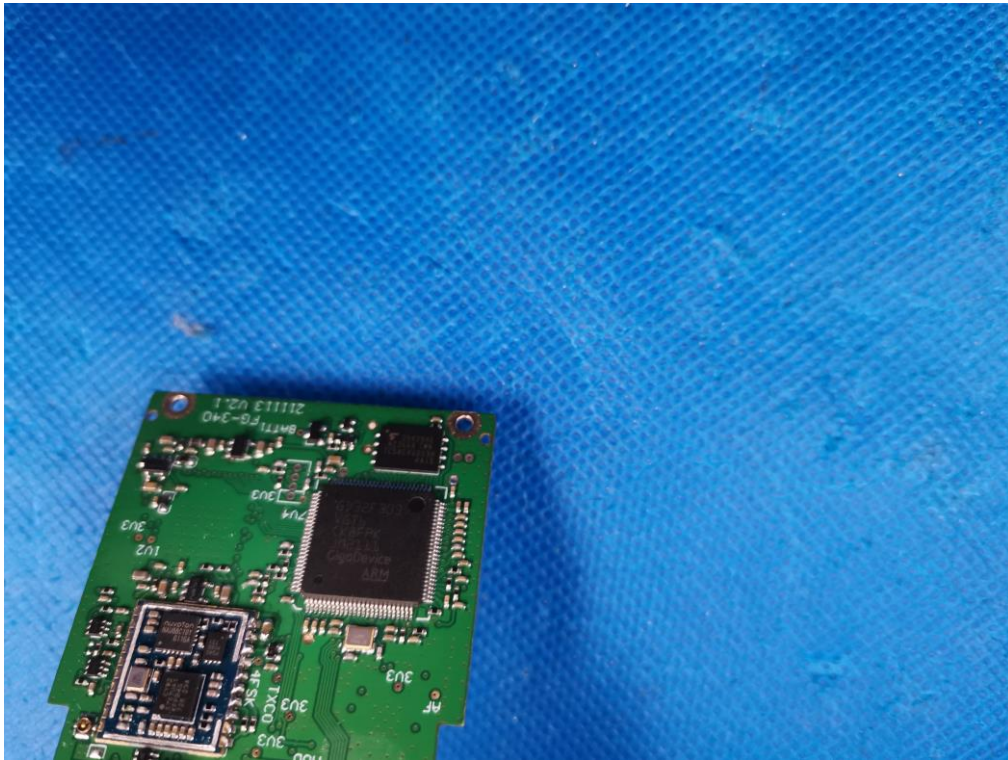

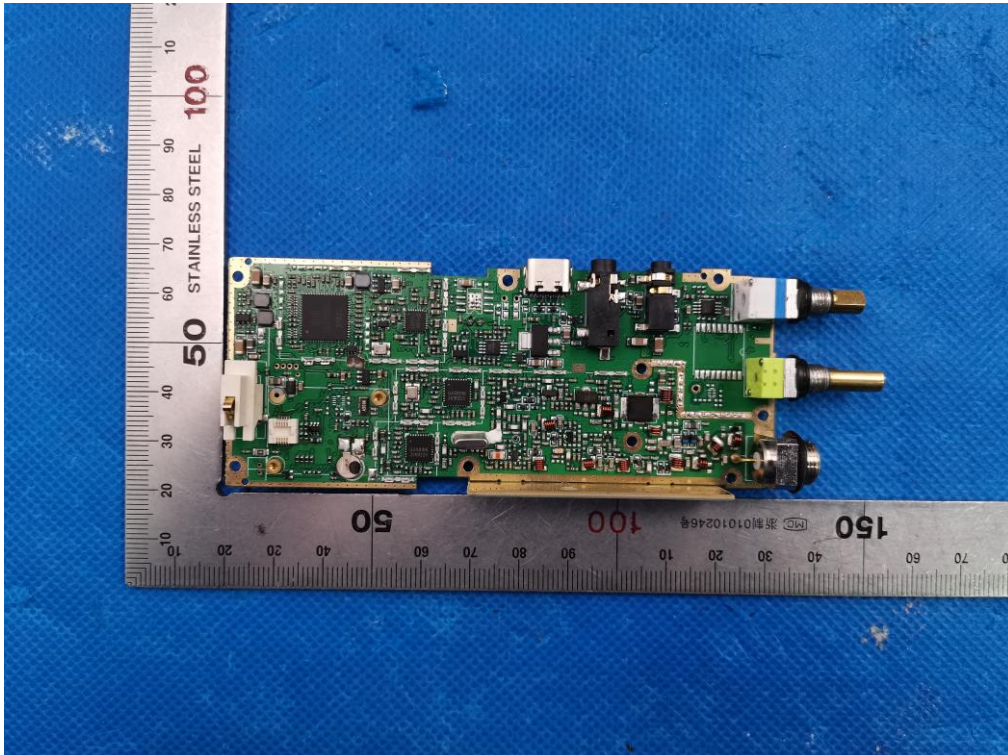

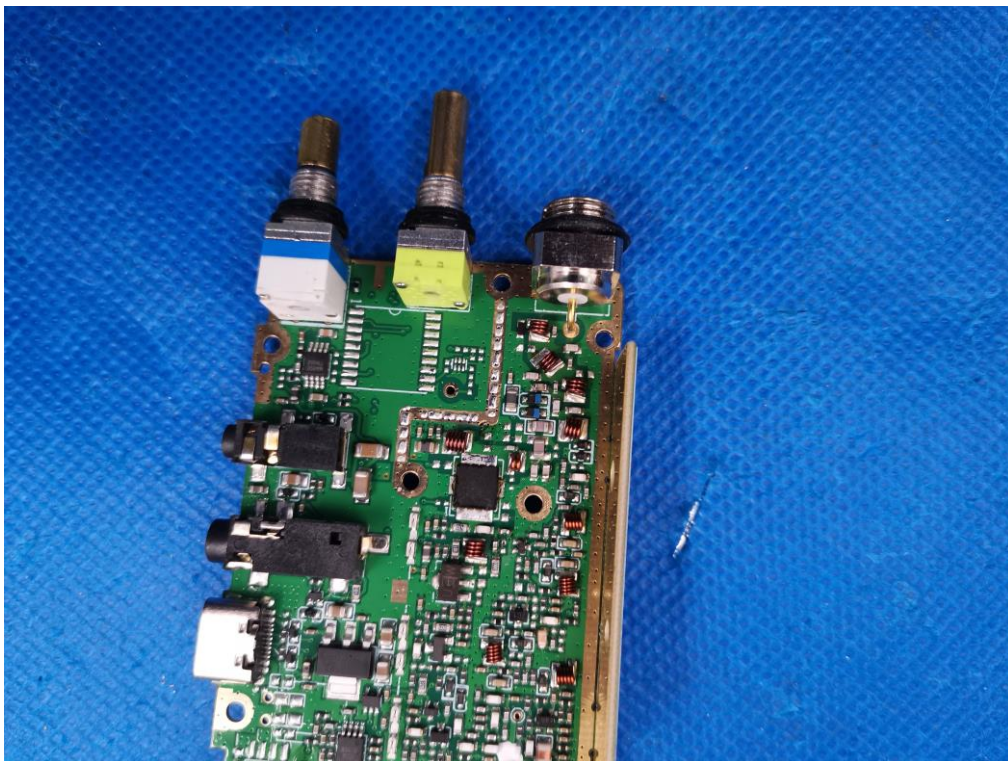

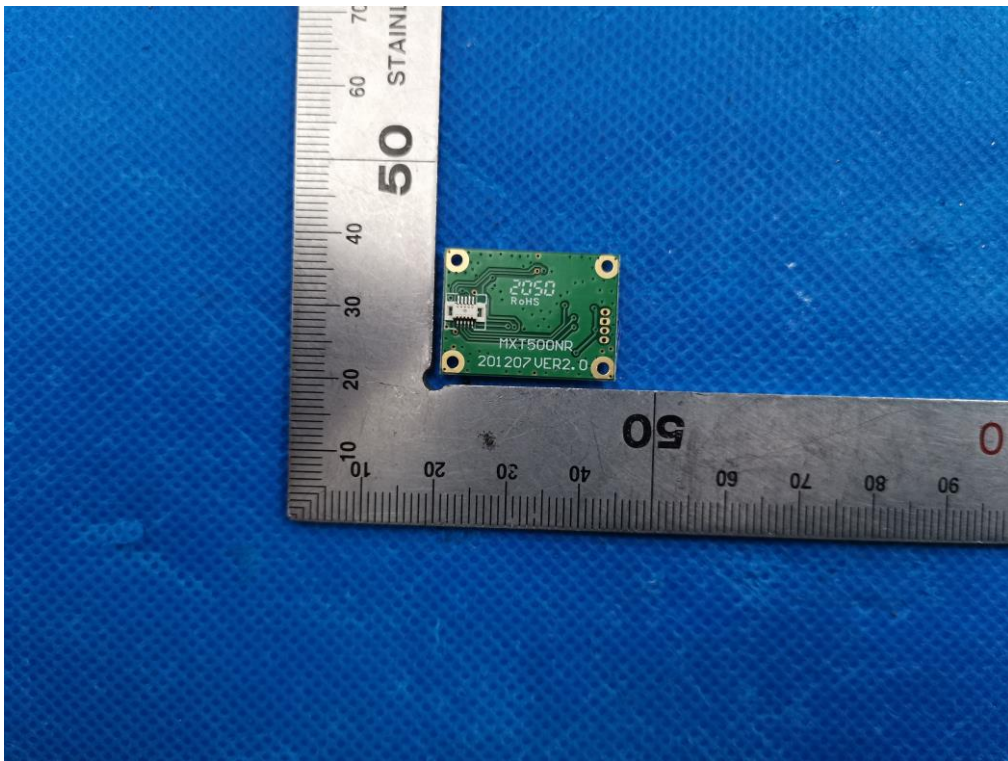

INTERNAL VIEW OF EUT(FIGURE 14)

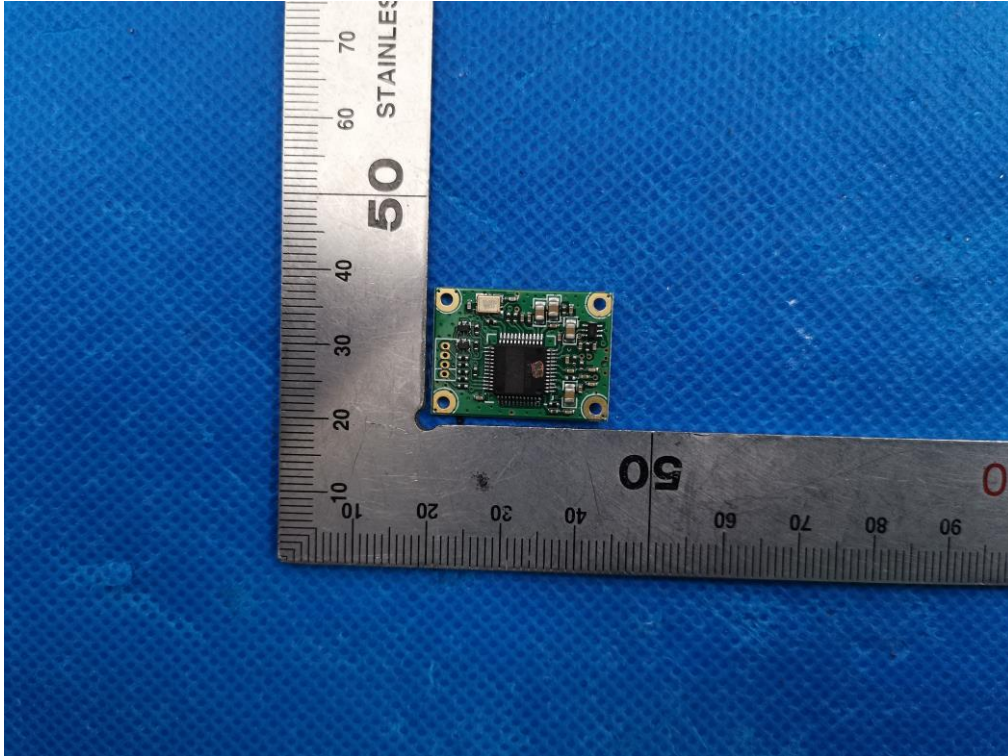
