Dear Eric Wong,

I have performed the review of the above referenced TCB application and find that the following items need to be addressed before the review can be completed:

1. The Request for Confidentiality submitted with this application does not contain the FCC ID number of the application. Please submit a revised Confidentiality Request letter that includes the FCC ID number of this device.
2. The test report does not document the version of the ANSI C63.4 measurement procedure used. Please provide a revised Test Report exhibit that documents the version of the ANSI C63.4 measurement procedure used.
3. FCC 15.203 requires specific compliance with antenna requirements, preventing standard connectors from being used on all Pt. 15 transmitters. The schematic diagram shows that the antenna connector on this PCI card is an SMA type, which is considered a standard connector by the FCC. Please provide compliance with FCC 15.203 requirement and provide additional photos showing the connector used. Also, please provide the specification sheet for the 605GR antenna used.

Please note that the Spurious Conducted Emissions have been performed at channel 2472MHz, when the highest channel of operation for this application is 2462MHz.

There is no need to re-measure this device's spurious emissions because of this situation since the emissions at 2472MHz still complied with the FCC requirements, but you should for future applications measure using the high channel available in the US device.

The items indicated above must be submitted before processing can continue on the above referenced application. Failure to provide the requested information within 30 days of the original e-mail date may result in application dismissal and forfeiture of the filing fee. Also, please note that partial responses increase processing time and should not be submitted.
