Please address following issues.

Q#1: Label format only indicates the product label format which doesn't agree the item #6 listed in module approval request letter. Please provide another label format when installing to a host.

Besides, since this mini-PCI card is laptop used that FCC DOC rule shall be complied and DOC logo shall included in the label. Please revise the label format to include the DOC logo.

Q#2: Two antenna connectors are shown on EUT, block diagram and user manual but test setup photos only indicates only a antenna was connected during the test. Please clearly

specify which antenna connector is connected and future application will be required when another connector is connected.

Q#3: User manual can't be kept as long term confidentiality, especially for this consumer device. So please remove it from the confidentiality request list.

Q#4: User manual indicates the warning statement for 5GHz which doesn't agree with this application. Please remove.

Q#5: Page 35 of RF exposure indicates this mini-PCI card is a portable device, required SAR evaluation which doesn't not agree with module approval requirement. Please address.
