Under normal operating conditions, the antenna is designed to be installed in accordance with the manufacturer's instructions in such a manor to maintain the minimum separation distance. As can be seen from the MPE results, this device passes the specified limits at a distance of 20cm at the maximum output power under normal operating conditions.
