that we have followed the testing strategy based on the reuse of:

- **The conducted RF test results** from the product NTG7Q MID with HW version D11 and SW version E329. Thus, radiated tests have been performed in the devices under test to grant full compliance with RED, FCC and ISSED regulations.
- **The SAR results** under RED standards from the tested model NTG7Q MID with HW version D11 and **RF Exposure assesments** under FCC/ISED standards from the NTG7Q MID, NTG7Q HIGH, NTG7Q PREMIUM with HW version D11 and SW version E329.

All 4 NTG7Q products with HW version D15 and SW version E444.201 are using the **identical BT/WLAN module** with the same RF path and antennas. Based on this declaration, the conducted test results performed over one product can be leveraged among the rest and the RF Exposure results can be reused from D11 versions.
