3. HAZARDS IDENTIFICATION

4. FIRST AID MEASURES

Contact with skin:

Immediately take off all contaminated clothing.

Areas of the body that have - or are only even suspected of having - come into contact with the product must be rinsed immediately with plenty of running water and possibly with soap. Contact with eyes:

Wash immediately and thoroughly with running water, keeping eyelids raised, for at least 10 minutes. Following this, protect the eyes with sterile gauze or a clean, dry, handkerchief. OBTAIN A MEDICAL EXAMINATION.

Swallowing:

Induce vomiting. SEEK A MEDICAL EXAMINATION IMMEDIATELY and present the safety-data sheet.

A suspension of activated charcoal in water, or liquid paraffin may be administered. Inhalation:

Ventilate the premises. The patient is to be removed immediately from the contaminated premises to rest in a well ventilated area. OBTAIN MEDICAL ATTENTION.
