Ericsson AB requests a Permissive Change (Type Acceptance) for the above mentioned FCC Identifier.

This base station transceiver (Radio Unit – RU) is designed for use in the WCDMA 2100 MHz cellular telephone system. The transmitter will operate from 2112.4 to 2152.6 MHz with 4.17 MHz Bandwidth. The receiver circuit supports 1712.4 to 1752.6 MHz. The base station operates in the 2100 MHz broadband PCS services as per 47 CFR Part 27 subpart L.
