To Whom It May Concern:

Ericsson AB requests a Permissive Change (Type Acceptance) for above mentioned FCC identifier.

This Radio Unit GSM (RUG 11 B2) is designed for use in GSM 1900 MHz cellular telephone system. The transmitter will operate in band 2 from 1930 MHz to 1990 MHz. The receiver circuit supports 1850 to 1910 MHz. This Radio Unit GSM (RUG 11B2) supports modulation type GMSK, 8PSK, for GSM. This Radio Unit GSM (RUG 11 B2) is appropriate to use in different Ericsson radio base stations without re-measurement and re-filing when introducing a new base station type. The base station operates in the 1900 MHz broadband PCS services as per 47 CFR Part 24 subpart E. It meets the requirements of 3GPP specification for operation in GSM 1900 cellular systems.

Due to the too wide frequency spectrum at the band edges, the channel 512 – 1930.2 MHz and channel 810 - 1989.8 MHz can not be used.

- 1) This Permissive Change request for this Radio Unit GSM (RUG 11 B2) is to include modulation type 16QAM and 32QAM for GSM
- 2) This Permissive Change request includes improving some weakness for this Radio Unit GSM (RUG 11 B2) and replacing some components because of lack to buy.

Ericsson AB requests confidentiality under CFR 0.459 according to attached letter.
