New functionality NR has been added in software to Band 85A and new functionality (the added NB-IoT functionality to NR) has been added in software to both Bands (B71 & B85A), as described/covered in Exhibit 12 and supporting documentation.

The radio operates in the Personal Communications Services and Miscellaneous Wireless Communications Services as per FCC 47 CFR Part 27.

This radio (Radio 4480 44B71 44B85A C) is designed for use in LTE, NB IoT (IB, GB, SA), NR cellular telephone system. This FDD radio operates in Band71 and B85A.

Band 71: Transmitter from 617 - 652 MHz and the receiver from 663 - 698 MHz.

Band 85A: Transmitter from 728 - 745 MHz and the receiver from 698 - 715 MHz.

Details regarding supported functionality, see clause 1.1 and 1.2 in Exhibit 12 – Technical Circuit Description.

This radio will always require a license for transmission.

The Exhibit 8 - manuals submitted with this application is generic and may cover multiple products.

This application is only valid for the model specified in the Exhibit 6- test report.


