Gentlemen;

Ericsson AB requests a Permissive Change (Type Acceptance) for above mentioned FCC identifier.

This base station transceiver (sTRX) is designed for use in WCDMA 1900 MHz cellular telephone system. The transmitter will operate from 1932.5 to 1987.56 MHz with 4.2 MHz Bandwidth. The receiver circuit supports 1852.5 to 1907.5 MHz. This base station transceiver (sTRX) supports modulation type QPSK and 16QAM. The transceiver has to be used together with a PAU (separately certified) and a sAIU which is a unit containing, among other circuits, a filter for the transmitted signal. The base station operates in the 1900 MHz broadband PCS services as per 47 CFR Part 24 subpart E. It meets the requirements of 3GPP specification for operation in WCDMA cellular systems.

This base station radio transceiver (sTRX) will in normal mode operate at a nominal output power of 42.4 dBm (typical value) at the output connector (antenna reference point).

The Permissive Change request is for the base station transceiver (sTRX) to also support modulation type 64QAM.

Ericsson AB requests confidentiality under CFR 0.459 according to attached letter.
