Ericsson AB requests a Grant of Certification (Type Acceptance) for the above mentioned FCC Identifier.

This base station transceiver - RRUS 11 B4 is designed for use in WCDMA, CDMA and LTE 1700/2100 MHz cellular telephone system, it also support MSR combination with CDMA and LTE; WCDMA and LTE. The transmitter will operate from 2110 MHz to 2155 MHz. It supports Channel Bandwidth of 1.4, 3, 5, 10, 15 and 20 MHz for LTE, 4.2 MHz and 5 MHz for WCDMA and 1.25MHz for CDMA. The receiver circuit supports 1710 MHz to 1755 MHz. This remote radio unit (RRU) supports modulation type QPSK, 16QAM and 64QAM for WCDMA and LTE, QPSK, 8PSK and 16QAM for CDMA. The base station operates in the AWS services as per 47 CFR Part 27 subpart L. It meets the requirements of 3GPP specification for operation in WCDMA, LTE and CDMA cellular systems.

This remote radio unit (RRU) will in normal mode operates at a nominal power out of 10, 20, 30 and 40 watts at each of the output connectors.

The Exhibit 8 user manuals submitted with this application is generic and may cover multiple products. This application is only valid for the model specified in the Exhibit 12 circuit description.
