1.4 Test Facility

The open area test site and conducted measurement facility used to collect the radiated data is located on the address of SGS Taiwan Ltd. No. 134, Wu Kung Rd., Wuku Industrial Zone, Taipei Country, Taiwan. The Open Area Test Sites and the Line Conducted labs are constructed and calibrated to meet the FCC requirements in documents ANSI C63.4: 2003 and CISPR 22/EN 55022 requirements. 2. SYSTEM TEST CONFIGURATION

2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

2.2 EUT Exercise

The EUT (Transmitter) was operated in the engineering mode to fix the Tx frequency which was for the purpose of the measurements.

2.3 Test Procedure

2.3.1 Conducted Emissions

The EUT is placed on a turn table which is 0.8 m above ground plane. According to the requirements in Section 7&13 of ANSI C63.4-2003.Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-Peak and Average detector mode.

2.3.2 Radiated Emissions

The EUT is placed on a turn table which is 1.0 m above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter(EUT) was rotated through three orthogonal axes according to the requirements in Section 8&13 of ANSI C63.4-2003.

Fig. 2-1 Configuration of Tested System



4. DESCRIPTION OF TEST MODES

The EUT has been tested under operating condition.

EUT staying in continuous transmitting mode. Channel low, Mid and High for each type and band with rated data rate are chosen for full testing.

The GSM module was approved and the FCC ID number is <u>**PY76220511**</u>. Thus, the output power, ERP/EIRP and Field Strength of Spurious Radiation were tested.



5.3 Measurement Procedure

The transmitter output was connected to a calibrated attenuator, the other end of which was connected to a power meter. Transmitter output was read off the power meter in dBm. The power output at the transmitter antenna port was determined by adding the value of the attenuator to the power meter reading.






(A) Radiated Emission Test Set-Up, Frequency Below 1000MHz





6.3 Measurement Procedure

The EUT was placed on an non-conductive turntable using a non-conductive support. The radiated emission at the fundamental frequency was measured at 3 m with a test antenna and EMI spectrum analyzer.

During the measurement, the EUT was communication with the station. The highest emission was recorded with the rotation of the turntable and the lowering of the test antenna from 4m to 1m. The reading was recorded and the field strength (E in dBuV/m) was calculated.

ERP in frequency band 824.2 –848.80.8MHz were measured using a substitution method. The EUT was replaced by dipole antenna connected, the S.G. output was recorded and ERP was calculated as follows:

EIRP in frequency band 1850.2–1909.8MHz were measured using a substitution method. The EUT was replaced by or horn antenna connected, the S.G. output was recorded and EIRP was calculated as follows:

ERP = S.G. output (dBm) + Antenna Gain (dBd) – Cable Loss (dB)

EIRP = S.G. output (dBm) + Antenna Gain (dBi) – Cable Loss (dB)


7.1 Standard Applicable

According to FCC §2.1053,

FCC \$22.917(a), \$24.238(a), the magnitude of each spurious and harmonic emission that can be detected when the equipment is operated under the conditions specified in the instruction manual and/ or alignment procedure, shall not be less than $43 + 10 \log$ (mean output power in watts) dBc below the mean power output outside a license's frequency block (-13dBm)


(A)Radiated Emission Test Set-Up, Frequency Below 1000MHz





7.3 Measurement Procedure

The EUT was placed on a non-conductive, The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and the EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. This maximization process was repeated with the EUT positioned in each of its three orthogonal orientations.

The frequency range up to tenth harmonic was investigated for each of three fundamental frequency (low, middle and high channels). Once spurious emission were identified, the power of the emission was determined using the substitution method.

The spurious emissions attenuation was calculated as the difference between radiated power at the fundamental frequency and the spurious emissions frequency.

ERP = S.G. output (dBm) + Antenna Gain(dBd) – Cable Loss (dB)

EIRP = S.G. output (dBm) + Antenna Gain(dBi) – Cable Loss (dB)
