NOTE:

The measured PEAK EIRP @30m proofs that the EUT antenna gain is far below 0dBi and that considering the max. declared output power of 22.55 dBm (=180 mW) is by far larger than the EIRP. Thus for it is correct to use the conducted value as the worst case base for the RF exposure calculation.

(3a) Standalone SAR test exclusion below 100 MHz at test separation distances > 50mm and < 200mm

(Threshold_{100MHz > 50mm}) \times (1+log(100/f))

where

Threshold_{1-g;10-g} is 3 for 1-g; 7.5 for 10-g

d_{seperation} is the min. test separation distance (>50mm and <200mm)

f is the RF channel transmit frequency

Threshold_{50mm}; $_{100MHz} < _{50mm}$ is Threshold_{1-g;10-g} × d / f $_{0.5}$

with f = 100MHz and d=50mm
