Here are the remaining issues to be addressed:

A. I cannot open the updated Form 731 you submitted in PDF format. Please re-send. Without being able to read the Form 731, I can't tell if you answered the prior open question:

ADMINISTRATIVE

(2) The frequency range of operation is not specified in the Form 731 for either device. The frequency should be entered either as the center of the band for single-band operation, or the centers of the highest and lowest bands for multi-band operation.

B. The updated Confidentiality request asks for the internal photos to be held confidential. This is not normally allowed, on the basis that anyone can purchase the product and look at the inside. You should consider deleting this item from the Confidentiality request, or provide additional justification in the letter, such as: the device is potted, and would be damaged or destroyed by user entry.

15.19(a)(5) allows devices which are too small for the full text to be included on the device label, to place the required text either in the user manual or on the device package. A sticker could be used either for adding the text in the manual, or onto the package. The rule is not specific as to the outside of the packaging or inside of the lid, so either location would be acceptable. In any case you will need to specify which location will be used, either by description or illustration.

Thank you for the 731 forms and confidentiality request letters received today.

On another note, Roland's final review of the FCC labels and User manuals

indicate that neither of them carries the label text required in 15.19(a)(3):

"This device complies with part 15 of the FCC Rules. Operation is subject to

the following two conditions: (1) This device may not cause harmful interference, and (2) this device must accept any interference received,

including interference that may cause undesired operation."

When the device is smaller than the palm of a normal hand (as it is in these

cases), it is permissible to delete the text from the FCC ID label and place

it in the User manual. Similar text is now present in the User manuals, but

it is not identical to the text above.

Please resolve this issue as soon as possible.
