Review of this application is underway and no major issues are foreseen. However to expedite the Grant, I would like to raise one point prior to completion of the review.

The Request for Confidentiality asks that internal photos be kept confidential, among other items. The FCC asks for additional justification in the case of internal photos, on the grounds that usually anyone can purchase the product and open it to obtain this information. The FCC accepts the following as suitable justifications for keeping the internal photos confidential:

- 1) The device is sealed (no screws or other removable fasteners) and would be damaged or destroyed by the attempt to open it; and/or

- 2) The device is potted, and any attempt to examine the interior would damage or destroy it; or
- 3) The device is professionally installed, and access is limited to authorized personnel only.

Please re-submit the Request for Confidentiality, citing in addition to its existing text the added applicable statements (1) and/or (2) above; or, delete "Internal photos" from the list of exhibits to be held confidential.
