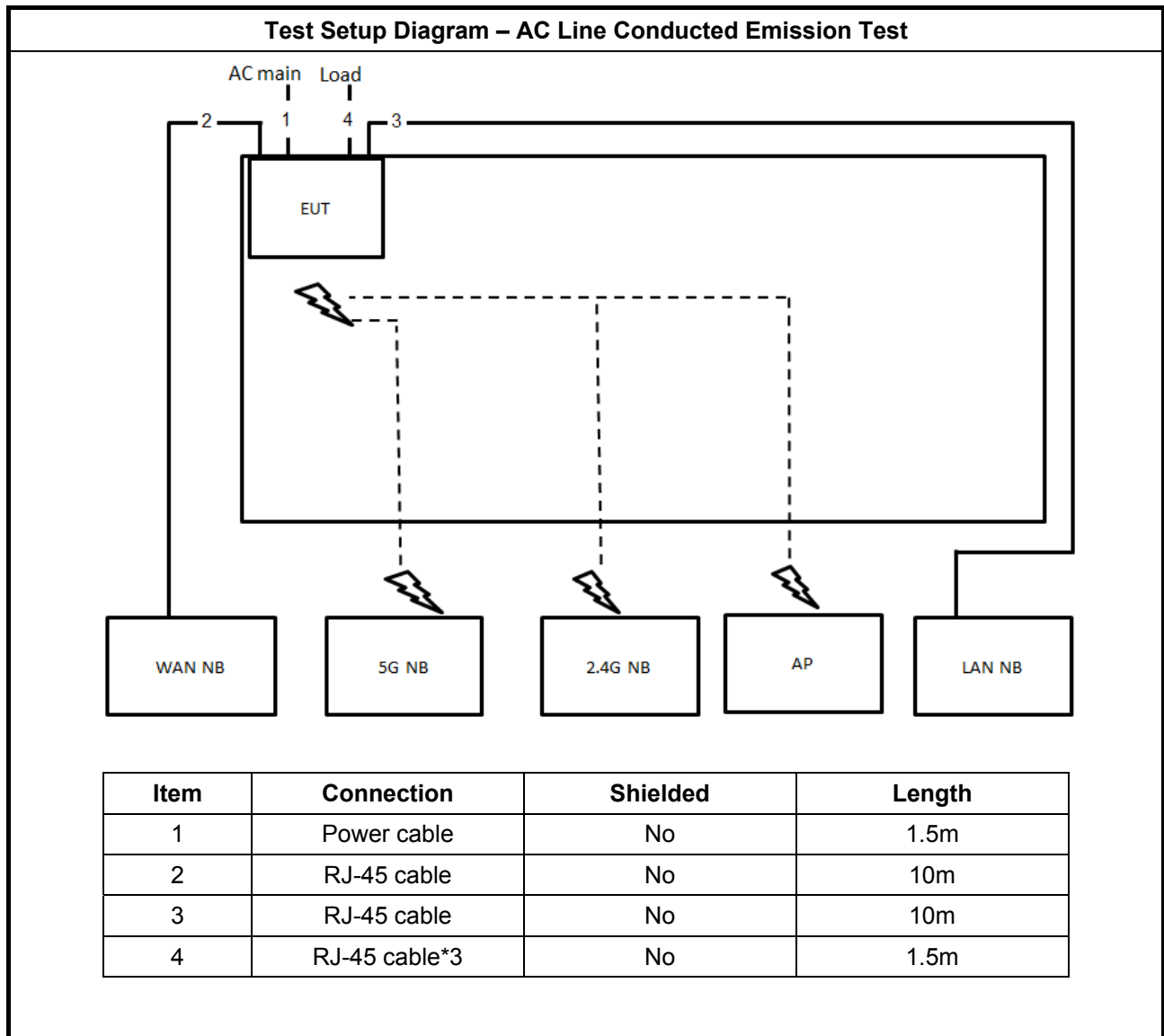

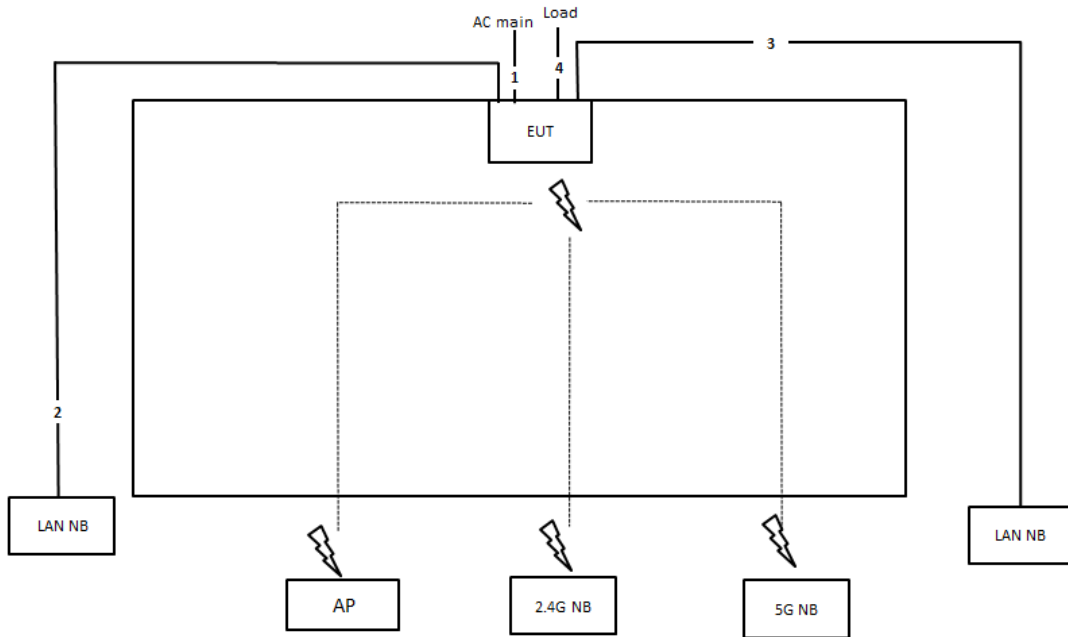

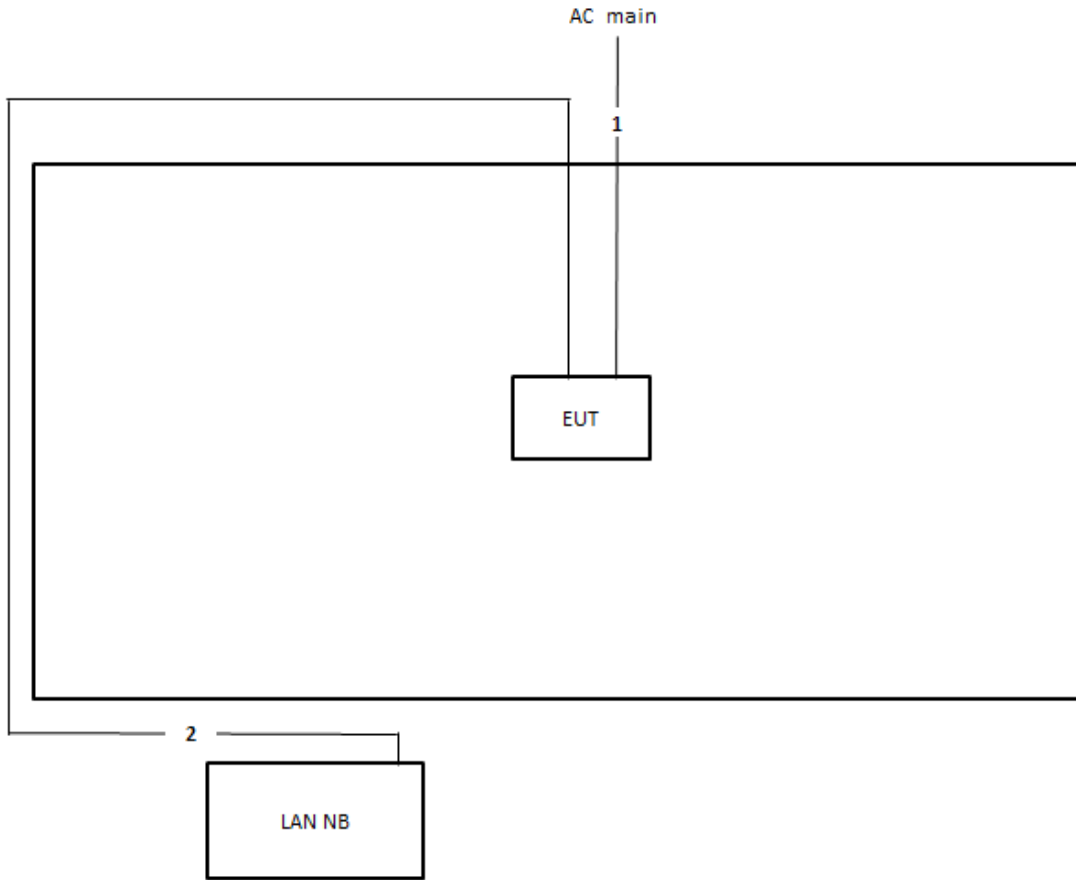


Test Setup Diagram - Radiated Test < 1GHz

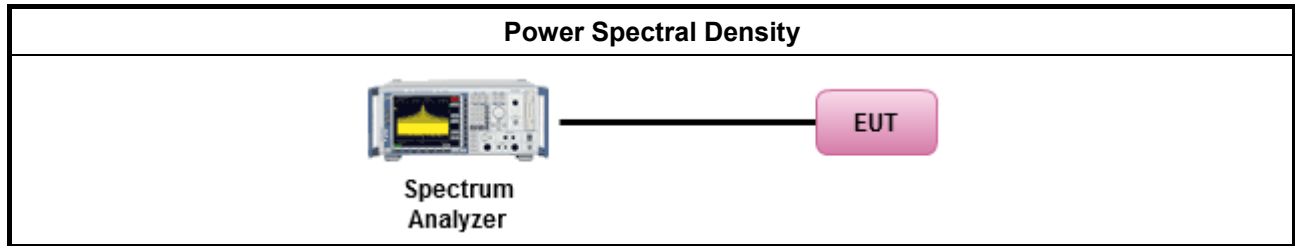
