2.2 MPE CALCULATION FORMULA

 $Pd = (Pout*G) / (4*pi*r^2)$

where

Pd = power density in mW/cm²

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

2.3 CLASSIFICATION

NOTE:

2.4GHz: Directional gain = 2dBi + 10log(3) = 6.77dBi **5.0GHz:** Directional gain = 3dBi + 10log(3) = 7.77dBi

CONCLUSION:

The formula of calculated the MPE is: CPD1 / LPD1 + CPD2 / LPD2 +etc. < 1

CPD = Calculation power density LPD = Limit of power density

WLAN 2.4GHz + WLAN 5GHz = 0.471 + 0.489 = 0.960

Therefore the maximum calculations of above situations are less than the "1" limit.
