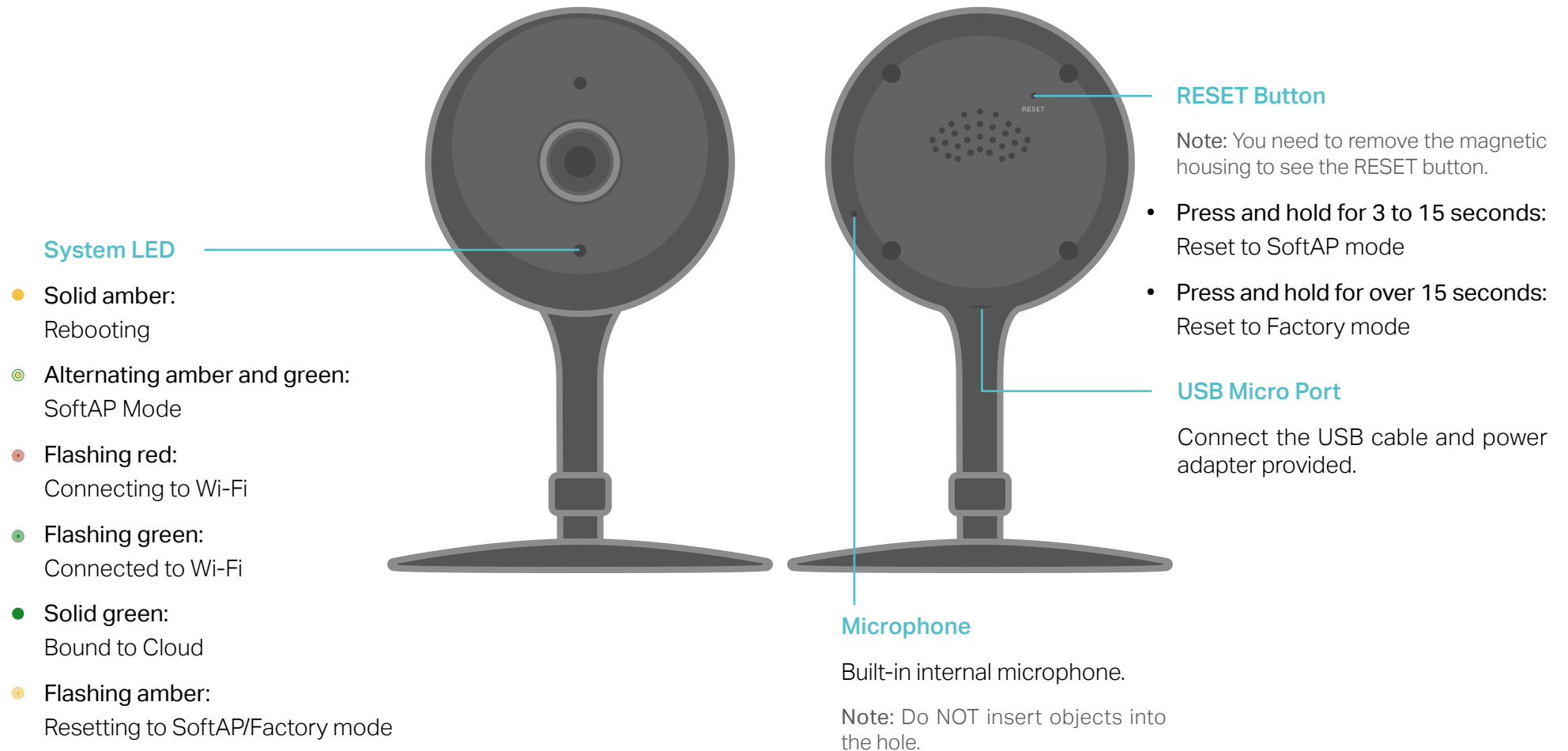

Follow the steps below to get started with your new camera.

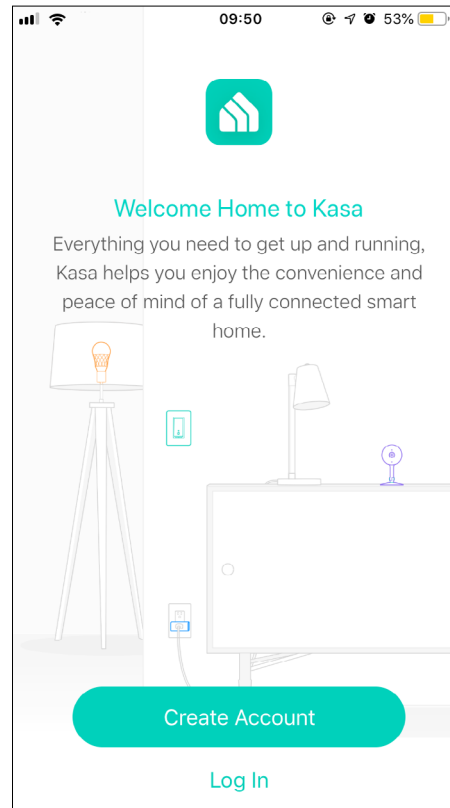
Step 1. Download Kasa

Get the [Kasa Smart](#) app from the Apple App Store or Google Play, or by scanning the QR code below.



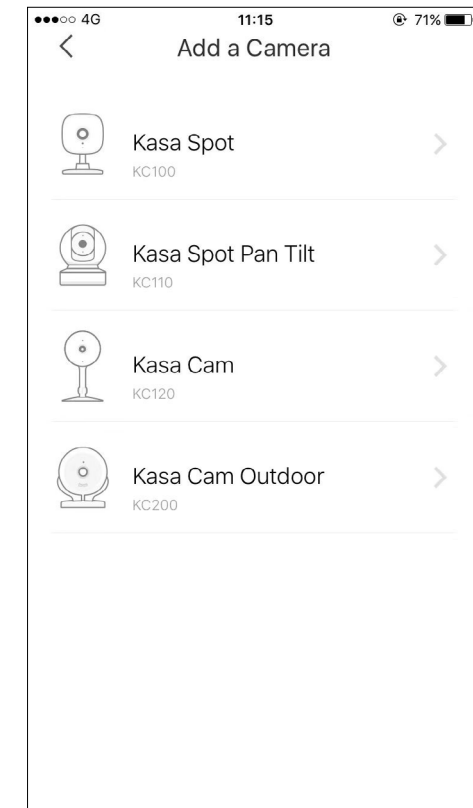
Step 2. Log In

Open the app, and log in with your TP-Link ID. If you don't have an account, create one first.



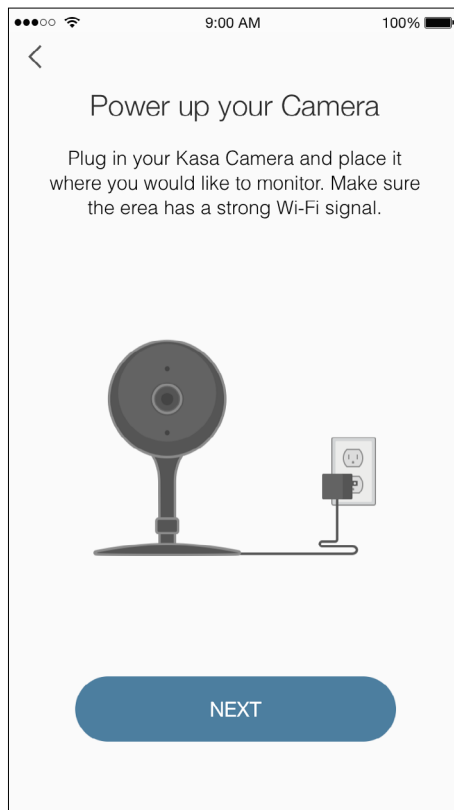
Step 3. Start Setup

Step 4. Configure Camera

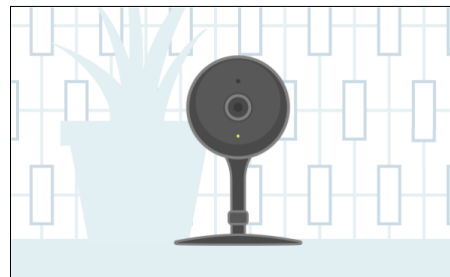
Follow app instructions to configure your camera and add it to your home network.



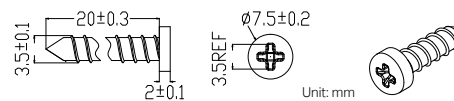
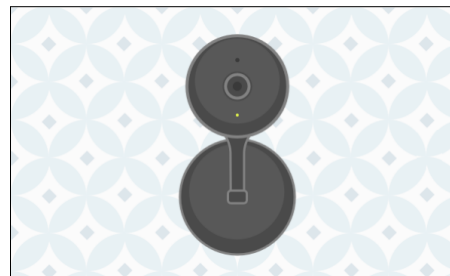
Step 5. Place Camera

- Install on a wall or ceiling



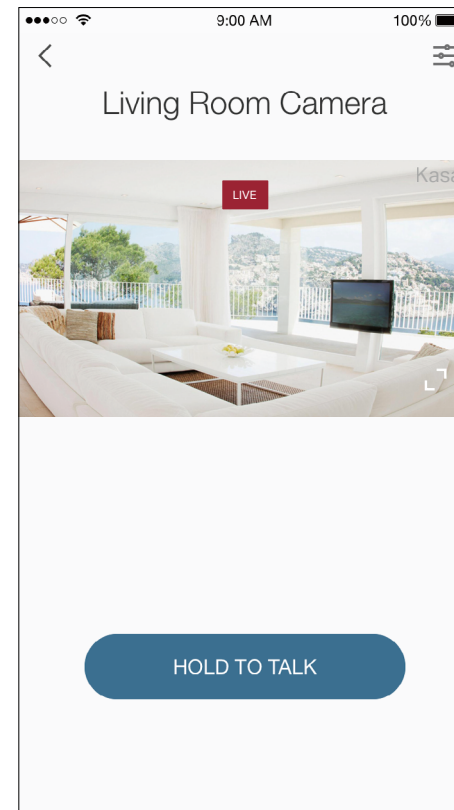
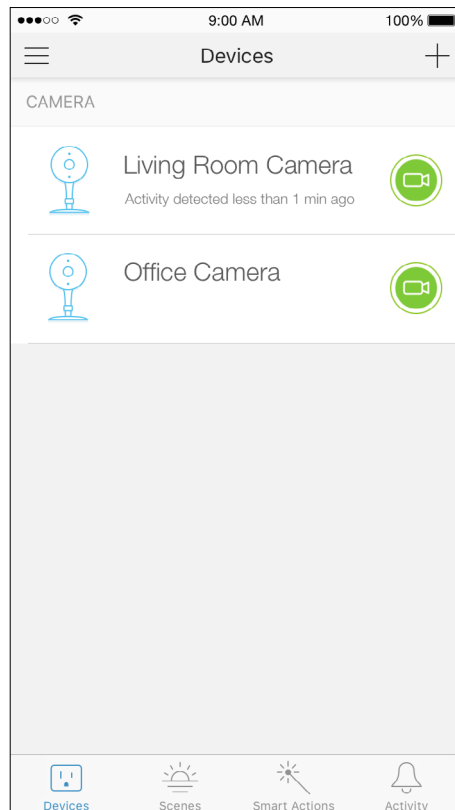
Use Your Camera

You can view your camera from anywhere at any time with your phone.

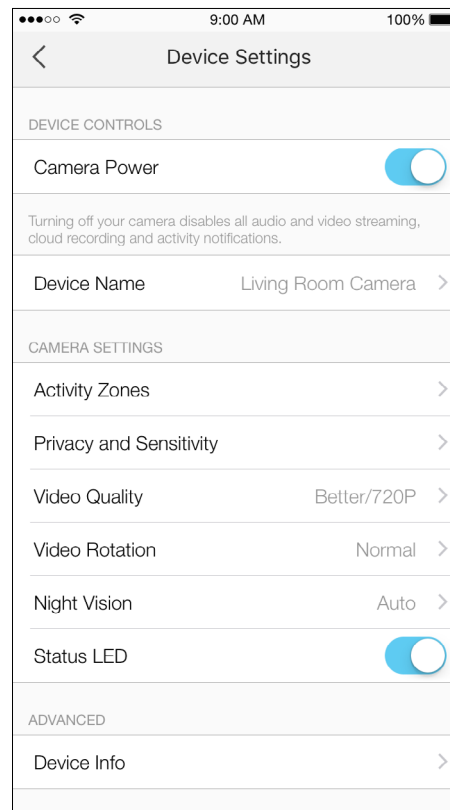
Go to the [Devices](#) page, then tap a camera to view the live video.

You can change the settings of your camera to meet various needs.

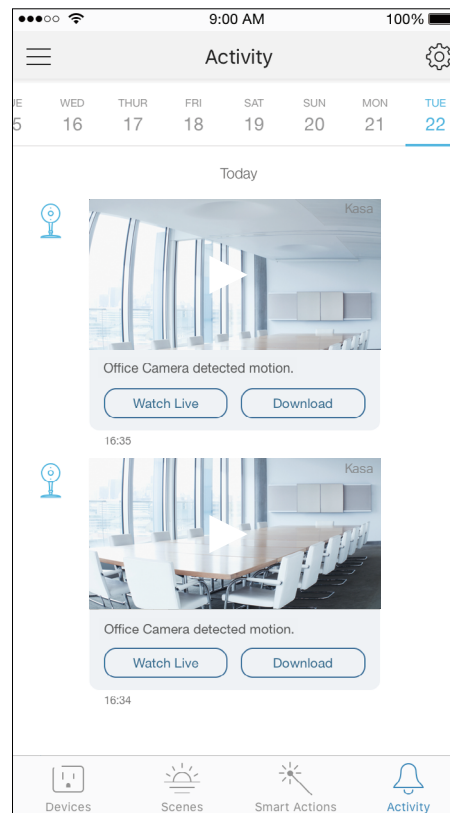
Go to the [Devices](#) page, tap a camera, then tap  to view and change camera settings.
