
### Step 2. Log In

### Step 3. Start Setup


Tap the  $\oplus$  button in the Kasa app and select Kasa Cam Outdoor.

### **Step 5. Install Outdoors**


Follow mounting instructions in the app to finish installation outdoors\*.




Tap  $\equiv$  on the live video page, then you can view and change camera settings.

When you receive an activity notification, you can check the live video immediately, or check the recordings at any time.


### **Check Activity History**

Tap 🐼 on the Activity page, then you can view and change notification settings.




