



7.1. Use Your Extender as a Wireless Adapter

The extender can be used as a wireless adapter to connect any wired-only device, such as a Blu-ray player, game console, DVR, or smart TV, to your wireless network.

After configuration, you can connect an Ethernet-enabled device to the extender via an Ethernet cable.




7.2. Transform Your Existing Wired Network to a Wireless One

The extender can work as an access point, transforming your existing wired network to a wireless one.

7. 2. 1. Set Up the Extender as an Access Point

- 1. Visit <u>http://tplinkrepeater.net</u>, and log in with your TP-Link ID or the password you set for the extender.
- 2. Click Mode in the top right corner of the page. Select Access Point and click Save. The extender will reboot and switch to Access Point mode.




