

致以 **FCC DoC** 方式行銷美國之客戶

自 1996 年 8 月 19 日起，貴公司的產品如果是 PC 和 PC 之週邊類而要以 DoC 方式行銷美國 (不須申請 FCC ID)，下列文件在以 DoC 方式行銷前必須準備齊全，以備 FCC 隨時抽查：

1. 測試報告 — 必須由 NVLAP 或 A2LA 認可之實驗室核發才有效。
2. Declaration of Conformity (DoC) Form — 必須由美國分公司或進口商簽名負責 (見附件二)。
3. 原始之設計圖稿及規格書 (如：線路圖、方塊圖、User Manual 和 Service Manual 等)。
4. 敘述製造時之生產檢查程序，以確保 EMI 特性之維持。
5. 任何會影響到 EMI 的變更敘述和必要之測試記錄。

附註：* 產品上要貼上 DoC 要求之 Label 標示 (見附件一)。

* Label 上和 User Manual 內要有 FCC Statement (內容同以前 FCC ID 之作法)。

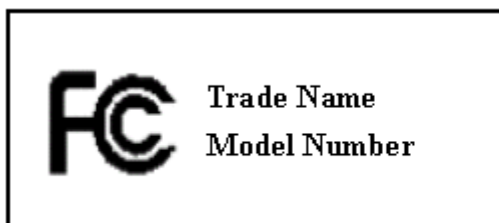
* DoC 簽名負責之廠商，有責任確保銷售之產品必須與當時檢驗樣品一樣，EMI 方面仍符合規定。

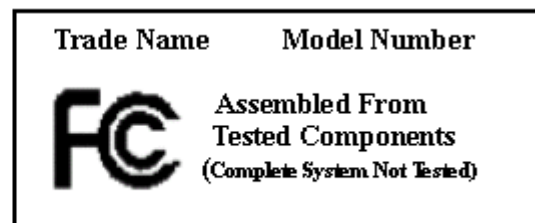
* 以上文件必須一份置於 DoC 簽名負責人手中備查。
