

#### 3. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4 and FCC CFR 47 2.1046, 2.1047, 2.1049, 2.1051, 2.1053, 2.1055, 2.1057, 15.207, 15.209 and 15.247.

#### 3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

#### 3.2 EUT EXERCISE

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

#### 3.3 GENERAL TEST PROCEDURES

#### **Conducted Emissions**

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

#### **Radiated Emissions**

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes according to the requirements in Section 13.1.4.1 of ANSI C63.4.

Until February 1, 1999, this restricted band shall be 0.490-0.510 MHz.

(b) Except as provided in paragraphs (d) and (e), the field strength of emissions appearing within these frequency bands shall not exceed the limits shown in Section 15.209. At frequencies equal to or less than 1000 MHz, compliance with the limits in Section 15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector. #### 3.5 DESCRIPTION OF TEST MODES

The EUT has been tested under operating condition.

Software used to control the EUT for staying in continuous transmitting and receiving mode is programmed.

IEEE802.11b: Channel 1(2412MHz), Channel 6(2437MHz) and Channel 11(2462MHz) with 11Mbps highest data rate (worst case) are chosen for the final testing.

IEEE802.11g: Channel 1(2412MHz), Channel 6(2437MHz) and Channel 11(2462MHz) with 6Mbps data rate (the worst case) are chosen for the final testing.

#### 5.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of Linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with pre-selectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

#### 5.3 LABORATORY ACCREDITATIONS AND LISTING

The test facilities used to perform radiated and conducted emissions tests are accredited by National Voluntary Laboratory Accreditation Program for the specific scope of accreditation under Lab Code: 200577-0 to perform Electromagnetic Interference tests according to FCC PART 15 AND CISPR 22 requirements. 
#### Peak power (CH Low)



## **TEST PROCEDURE**

- 1. The EUT is placed on a turntable, which is 0.8m above ground plane.
- 2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
- 3. EUT is set 10m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emissions.
- 4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- 5. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- 6. Repeat above procedures until the measurements for all frequencies are complete.

## 7.6 POWERLINE CONDUCTED EMISSIONS

## **LIMIT**

For an intentional radiator which is designed to be connected to the public utility (AC) power Line, the radio frequency voltage that is conducted back onto the AC power Line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases Linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). The limits at specific frequency range is listed as follows:



## **TEST PROCEDURE**

- 1. The EUT was placed on a table, which is 0.8m above ground plane.
- 2. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- 3. Repeat above procedures until all frequency measured were complete.

## **TEST RESULTS**

The initial step in collecting conducted data is a spectrum analyzer peak scan of the measurement range. Significant peaks are then marked as shown on the following data page, and these signals are then quasi-peaked.


