The MPE was calculated at 20 cm to show compliance with the power density limit.

The following formula was used to calculate the Power Density:

$$S = \frac{PG}{4\pi R^2}$$

Where:

- S = Power Density
- P = Output Power at Antenna Terminals
- G = Gain of Transmit Antenna (linear gain)
- R = Distance from Transmitting Antenna

5.1. Standalone Power Density Calculation
