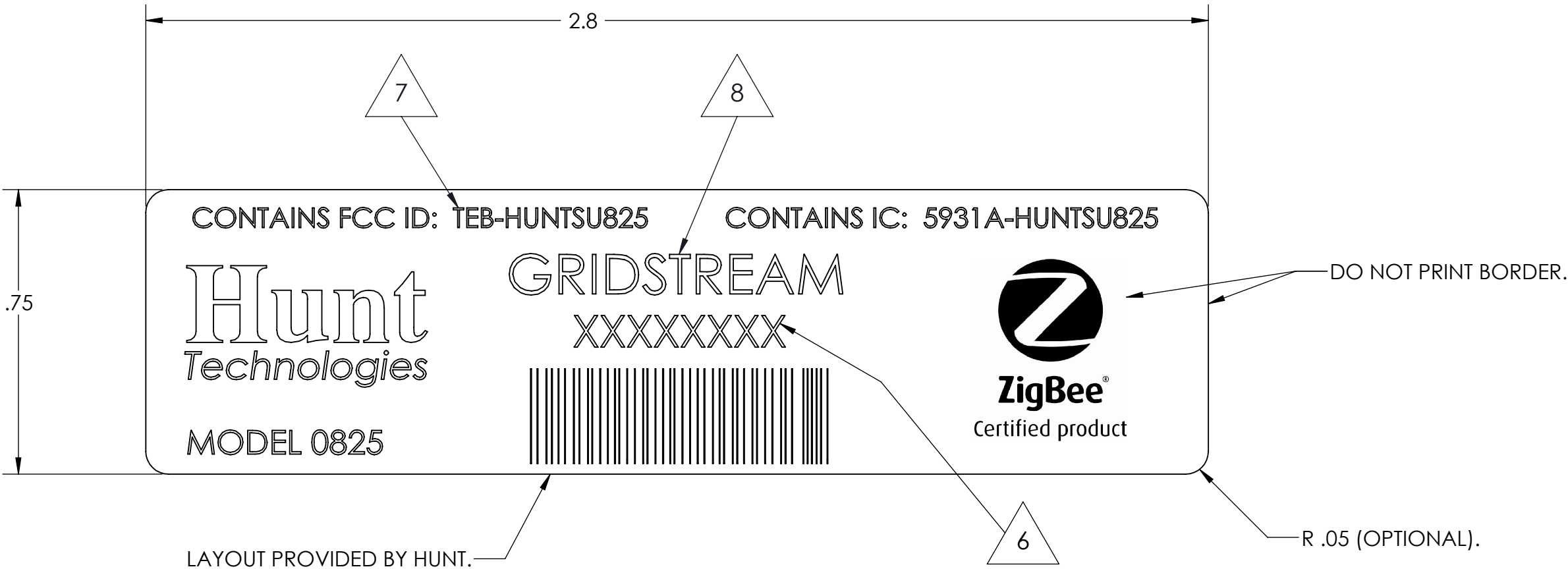

5. DIGITAL INKING SYSTEM FOR TEXT & BAR CODE TO BE PERMANENT BLACK, U.V. RESISTANT.
6. 8 DIGIT HEXIDECIMAL SERIAL NO. TO BE IMPRINTED IN HUMAN READABLE FORM BELOW THE 8 DIGIT SERIAL NUMBER. INFORMATION IN CODE 128C WITH NO SPACES. (BARCODE HEIGHT TO BE .150 MIN). THE BAR CODE CAN RUN OFF THE BOTTOM OF THE LABEL.
7. FCC I.D. NUMBER TO BE LISTED ACROSS THE TOP OF THE LABEL.
8. HUNT PRODUCT NAME LISTED AS SHOWN.
9. LABEL MANUFACTURER:

10. NARROW BAR IS 10 MIL.

THE SERIAL NUMBER ON THIS LABEL MUST MATCH THAT OF THE LABEL OF THE MODULE INSTALLED IN THE METER.
