


6.10. Conducted Spurious Emission Measurement

6.10.1. Test Specification

Test Requirement:	FCC Part15 C Section 15.247 (d)
Test Method:	ANSI C63.10:2013 and DA00-705
Limit:	In any 100 kHz bandwidth outside the intentional radiation frequency band, the radio frequency power shall be at least 20 dB below the highest level of the radiated power. In addition, radiated emissions which fall in the restricted bands must also comply with the radiated emission limits.
Test Setup:	 <p style="text-align: center;">Spectrum Analyzer EUT</p>
Test Mode:	Transmitting mode with modulation
Test Procedure:	<ol style="list-style-type: none"> 1. The testing follows the guidelines in Spurious RF Conducted Emissions of FCC Public Notice DA 00-705 Measurement Guidelines 2. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement. 3. Set to the maximum power setting and enable the EUT transmit continuously. 4. Set RBW = 100 kHz, VBW = 300kHz, scan up through 10th harmonic. All harmonics / spurs must be at least 20 dB down from the highest emission level within the authorized band as measured with a 100 kHz RBW. 5. Measure and record the results in the test report. 6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.

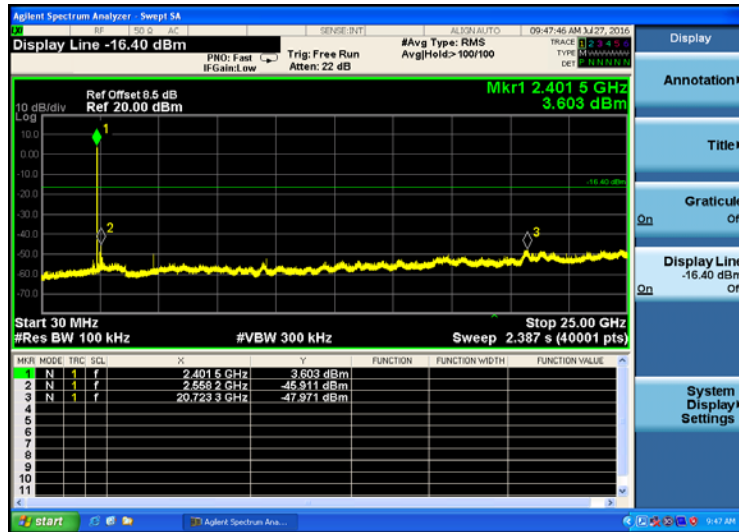

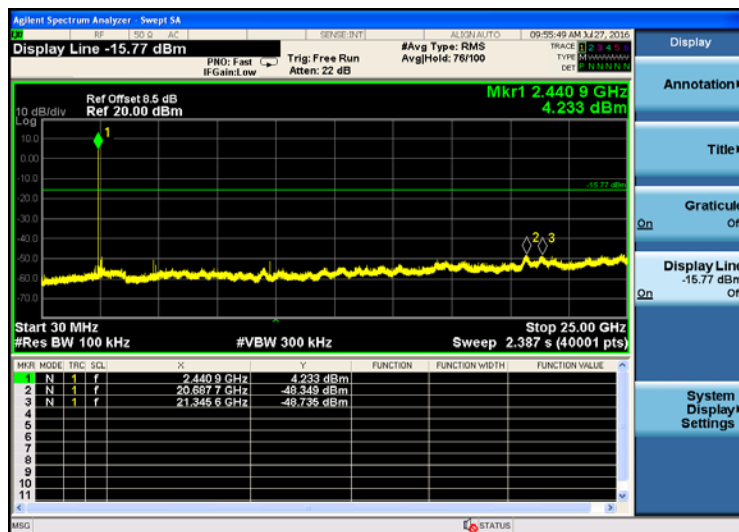

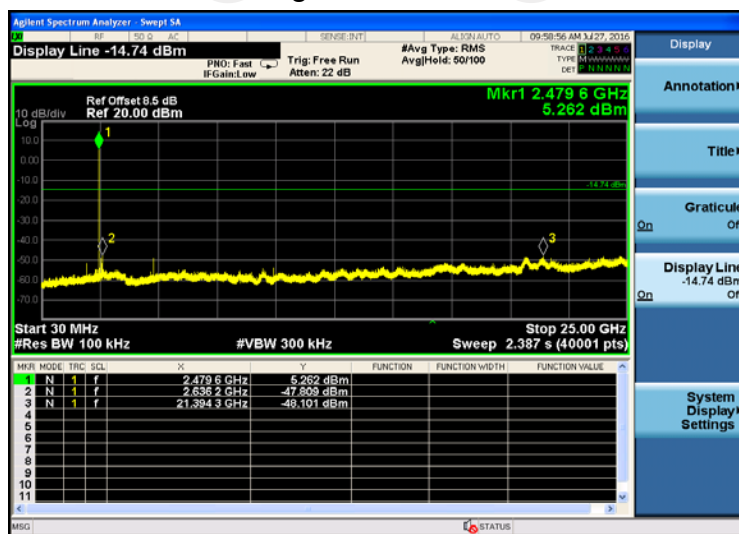
Lowest Channel



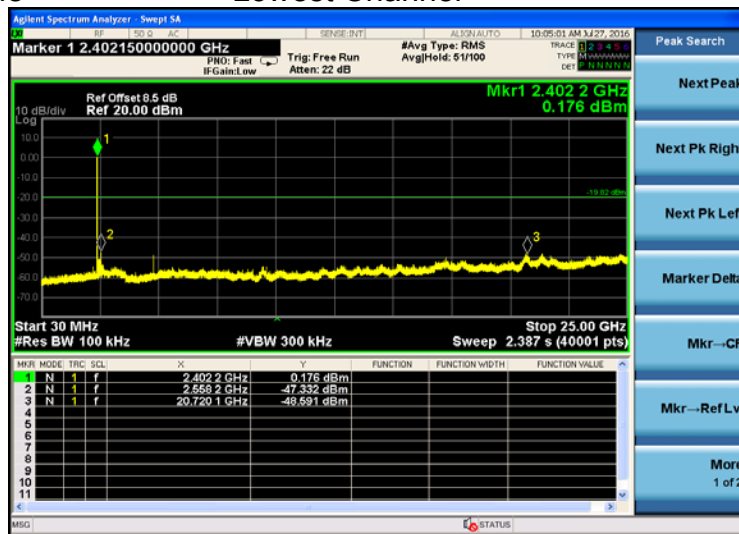
Middle Channel



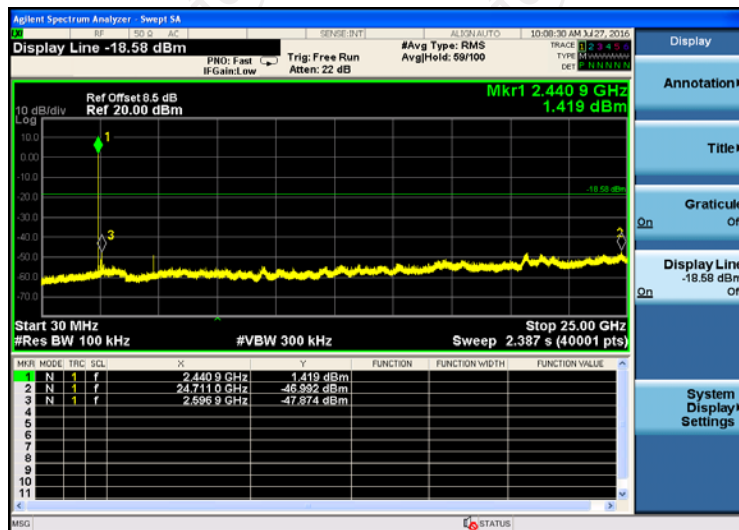
Highest Channel



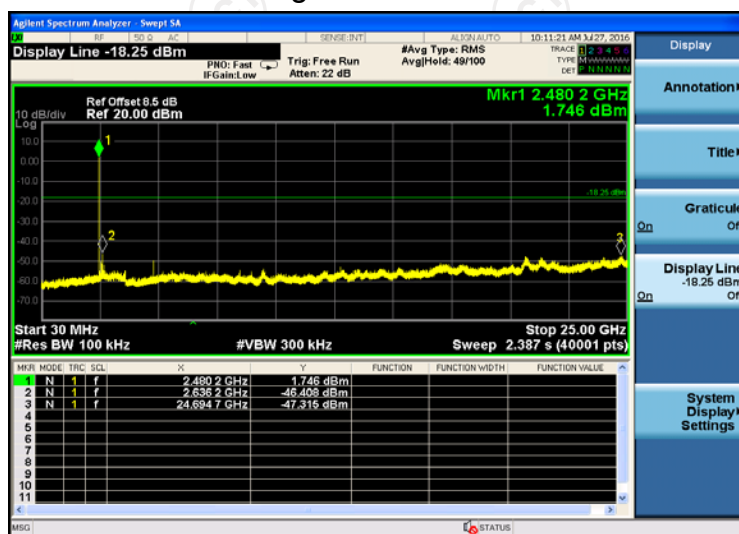
Pi/4DQPSK mode Lowest Channel

Test Procedure:

1. The testing follows the guidelines in Spurious Radiated Emissions of FCC Public Notice DA 00-705 Measurement Guidelines.
2. For the radiated emission test below 1GHz:
The EUT was placed on a turntable with 0.8 meter above ground. The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower. The EUT was arranged to its worst case and then tune the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high PASS filter are used for the test in order to get better signal level.
- For the radiated emission test above 1GHz:
Place the measurement antenna on a turntable with 1.5 meter above ground, which is away from each area of the EUT determined to be a source of emissions at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT,

	<p>depending on the radiation pattern of the emission and staying aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation for maximum emissions shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane.</p> <p>3. Set to the maximum power setting and enable the EUT transmit continuously.</p> <p>4. Use the following spectrum analyzer settings:</p> <p>(1) Span shall wide enough to fully capture the emission being measured;</p> <p>(2) Set RBW=100 kHz for $f < 1$ GHz, RBW=1MHz for $f > 1$GHz ; VBW\geqRBW; Sweep = auto; Detector function = peak; Trace = max hold for peak</p> <p>(3) For average measurement: use duty cycle correction factor method per 15.35(c). Duty cycle = On time/100 milliseconds On time = $N_1 * L_1 + N_2 * L_2 + \dots + N_{n-1} * L_{n-1} + N_n * L_n$ Where N_1 is number of type 1 pulses, L_1 is length of type 1 pulses, etc. Average Emission Level = Peak Emission Level + $20 * \log(\text{Duty cycle})$</p> <p>Corrected Reading: Antenna Factor + Cable Loss + Read Level - Preamp Factor = Level</p>

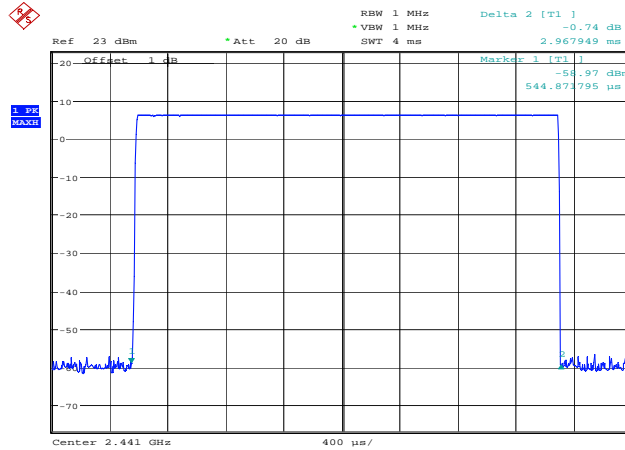

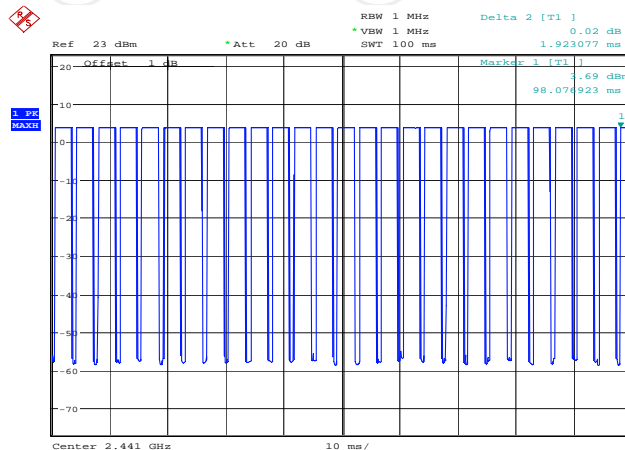
Duty cycle correction factor for average measurement

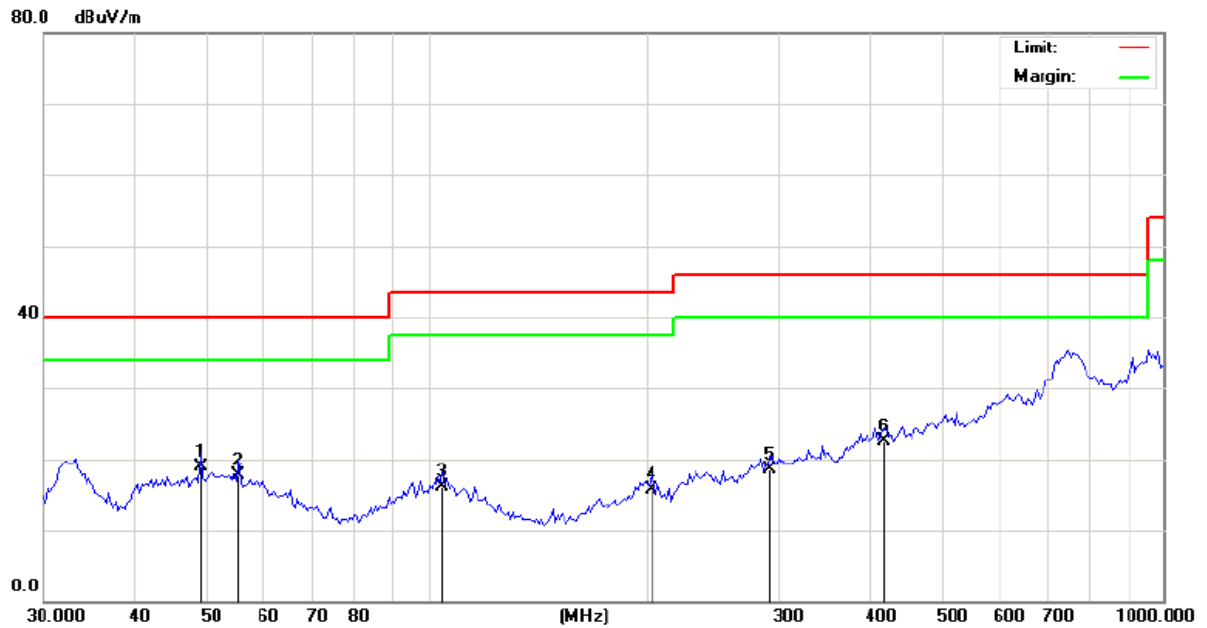
Note:

1. Worst case Duty cycle = on time/100 milliseconds = (2.968*26+1.923)/100=0.79091
2. Worst case Duty cycle correction factor = 20*log (Duty cycle) = -2.04dB
3. DH5 has the highest duty cycle worst case and is reported.
4. The average levels were calculated from the peak level corrected with duty cycle correction factor (-2.04dB) derived from 20log (dwell time/100ms). This correction is only for signals that hop with the fundamental signal, such as band-edge and harmonic. Other spurious signals that are independent of the hopping signal would not use this correction.

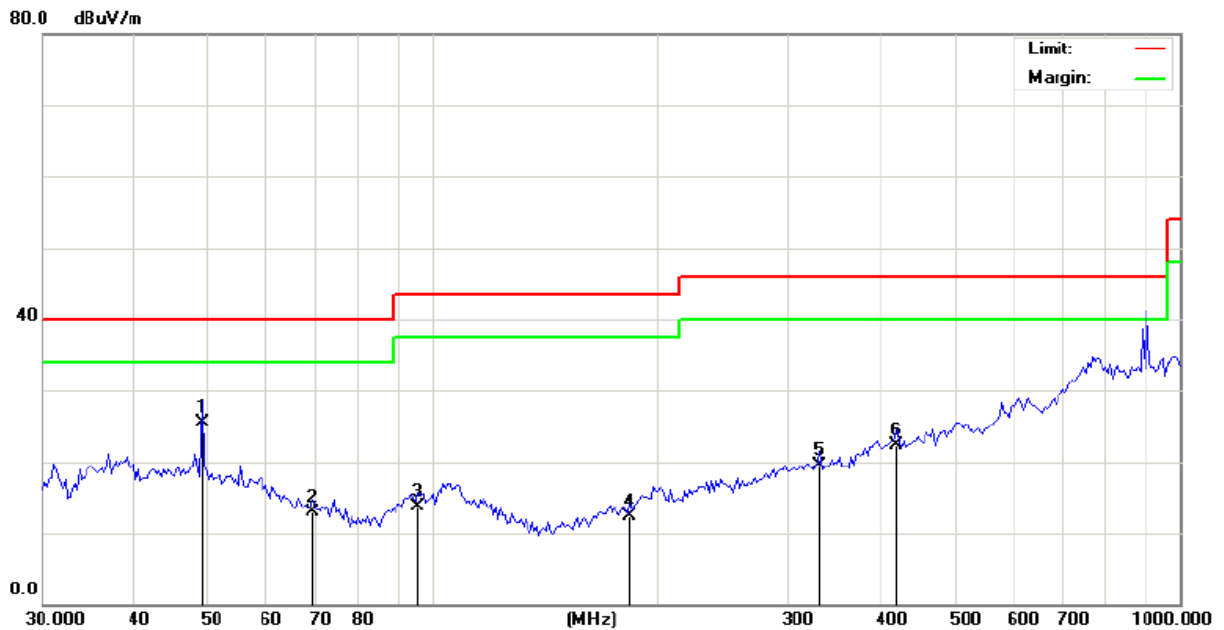
